REVIEW AND APPROVE AGENDA AND MINUTES / ANNOUNCEMENTS

Moved, seconded, and passed (8-0-0): "To approve the 4/22/15 agenda and the 4/8/15 CPC meeting minutes with no changes."

USE OF FORCE POLICY - DISCUSSION

The CPC discussed its proposed recommendations to the SPD Use of Force Policy. Brian Maxey of SPD participated in the conversation. The CPC will submit its recommendations to the parties by Friday, April 24. The final proposed policy changes will be submitted by the Monitor to the court by May 10, 2015. The CPC requested to speak to the stakeholders prior to final submission of the policy to the court to discuss the recommendations that were retained and those that were rejected.

BIAS-FREE POLICING POLICY - FEEDBACK

The CPC submitted recommendations to SPD about the Bias-Free Policing Policy. Some of the CPC's recommendations were incorporated into the new draft policy.

WORKGROUP UPDATES

Accountability Workgroup – Since late March, members of the CPC, the OPA Auditor and the Mayor's Office have been meeting to discuss the draft accountability legislation. Another meeting has been scheduled.

The SPD submitted its response to the OPA Auditor's Semi-Annual Report.

The CPC will review the OPA website and make initial recommendations to improve its content and accessibility. **Training Workgroup** – Commissioners may attend SPD trainings. Commissioners have expressed interest in attending the crisis intervention training and crowd control training. The SPD Bikes squad and Anti-crime teams will be attending the crowd control training. Bias-free policing training for supervisors will occur in May. Stops and detentions and bias-free policing training for all officers will be on-going from August through December. Commissioners will provide feedback to SPD regarding the curriculum for the bias-free policing training and possibly others.

SPD Community Engagement Assessment Workgroup – The community listening sessions will continue through May. The surveys have been translated into thirteen different languages for attendees. Interpreters will also be available at the sessions and will work with CPC to facilitate.

OTHER BUSINESS

CPC Community Engagement FTE interviews are planned for April 28th. The FTE candidate names and interview questions were shared with the commissioners to review and provide feedback. The Commission has received over 270 applications although many applications were incomplete or did not meet mandatory minimums. CPC Staff and Commissioners will sit on the interview panel.

- Staff will follow up with Matthew Barge of the Monitoring Team to request the CPC participate in the Use of Force Policy negotiations.
- Staff will submit the CPC's recommendations to the Use of Force Policy to the stakeholders by April 24.
