Appendix A

Schedule of Priorities for the Settlement Agreement

The following table categorizes the subject areas of the City's obligations under the Settlement Agreement and provides the Monitor's prioritization of those subject areas for implementation.

- <u>Priorities</u>: In the first column, we list our priorities (1-18), and cross-reference the City's priority designators (1A-4A).
- <u>Topic</u>: The second column lists the general topic that is prioritized and corresponds to the color codes of SPD's Matrix.
- <u>Sub-Topic</u>: The third column lists a sub-topic that is being prioritized. These subtopics are broken down into more general categories than the SPD Matrix does, and represents the way that the Monitor understands the SA provisions to be broken down.
- <u>Draft Deadline</u>: The fourth column states a deadline by which the City provides the Monitor a draft of the policy, training curriculum, or whatever other document is to be produced. These deadlines match those provided in SPD's Matrix. (Where no deadline was provided in SPD's Matrix, we proposed what we believe are reasonable deadlines based on SPD's Matrix and where the topic falls in the Monitor's list of priorities.) Provision of a draft document to the Monitor does not automatically require the Monitor and DOJ to review and comment within 45 days of submission. Instead, provision of a draft document begins a collaborative discussion with the Monitor about development of the policy, training curricula, implementation, and measurement.
- <u>Compliance Deadline</u>: The fifth column proposes what the Monitor believes to be a realistic deadline for the City to reach compliance with provisions. Note that the deadlines do not correspond chronologically to the priority for various reasons.
