Subject: Changes (Budget Actions) to Chair's Initial Balancing Package

Dear Councilmembers:

At the November 2 Budget Committee, Chair Burgess publicly discussed his Initial Balancing Package that included a series of changes to the Mayor's Proposed Budget. At the request of the Budget Chair, I am providing you a preview of all items that will be discussed at tomorrow's Budget Committee meeting (see attached worksheet). As you will see, none of these budget actions were included in the Chair's Initial Balancing Package. In other words, these items are either new ideas, re-statements of prior proposals, and/or revisions or additions to elements that were included in the Initial Balancing Package, such as the Councilmember Harrell's 13th Year request.

Each budget action included in the attached met the November 4th, 5 pm deadline for three sponsors and includes a proposal that would change the Chair's Initial Balancing Package. Tomorrow's agenda includes only discussion of these proposals, and there will be <u>no votes</u>. As you know, proposals submitted for tomorrow's discussion were not required to be "self-balancing" (no net impact on the general sub fund). However, the collective total cost of these new proposals is substantially greater than the unreserved fund balance available to fund these items. Please bear in mind, therefore, that in order to fund new asks, resources will have to be reprogrammed from other planned expenditures and/or priorities.

You should be able to review each budget action by clicking on the link provided. Please note that the worksheet contains multiple tabs that organize the list of budget actions as follows:

- 1. **"GSF GS IBP Only" Tab:** Budget actions that increase or change expenditures from the GSF.
- 2. **"Non-GSF Fund Changes" Tab**: Budget actions that increase or change expenditures from any other fund (i.e., not GSF).
- 3. "New SLIs" Tab: Budget actions that create new SLIs.
- 4. **"New Provisos & Legislation" Tab**: Budget actions that create either standalone provisos or standalone legislation.

This list of proposed budget actions will be made public this afternoon via the final agenda, including green sheets indicating the order in which the Budget Committee will discuss each item.
