This is a non-project legislative action proposing amendments to the land use code to define and add standards for short-term rental uses and modify the definition and standards for bed and breakfast uses. There is no specific site or development proposal.

The amendments will:

- Establish a new definition for “short-term rental” as a type of lodging use (SMC 23.84A.024);
- Establish standards for short-term rentals, including an annual rental limit of 90 nights for units that are not the primary residence of the owner (SMC 23.42.060);
- Modify the definition of “bed and breakfast” as a type of lodging use to include only those uses established before May 1, 2016 (SMC 23.84A.024);
- Modify the standards for bed and breakfasts as an accessory use in single-family and multi-family zones and relocate them to a new section of code (SMC 23.42.060, SMC 23.44.051, and SMC 23.45.545);
- Require that all short-term rentals and bed and breakfast uses have a business license from the City, and that short-term rental uses and bed and breakfasts uses that rent more than 90 nights in a year have a short-term rental license from the City (SMC 23.42.060);
- Eliminate regulations for roomers, boarders and lodgers as an accessory use in single-family zones (SMC 23.44.072);
- Modify signs regulations to allow signs on short-term rental uses in multifamily zones (23.55.022);
- Establish new definitions for “primary residence” and “short-term rental operator” (SMC 23.84A.030 and SMC 23.84A.036); and
- Make various updates and clarifications.

Bed and breakfasts are currently allowed as an accessory use in single-family and multi-family zones under existing regulations and will continue to be allowed under the proposal. The proposal creates a new category of lodging use, short-term rentals, which are currently not regulated or otherwise addressed in the land use code, and establishes requirements and limitations on the use that are not in place today. The proposed changes are not expected to alter the pace or scale of new residential development.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The proposed changes would result in no direct impacts, and are unlikely to result in indirect or cumulative impacts related to plant, animal, fish, or marine life. The eligible locations for lodging uses would not be significantly altered by the proposal, and the

proposal does not alter any procedures or regulations related to natural environment protections. The proposed changes are not expected to alter the pace or scale of new residential development.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:
None proposed.

3. How would the proposal be likely to deplete energy or natural resources?

The proposed changes would result in no direct negative impacts, and are unlikely to result in indirect or cumulative impacts related to energy or natural resources. The eligible locations for lodging uses would not be significantly altered by the proposal, and the proposal does not alter any procedures or regulations related to natural environment protections. The proposed changes are not expected to alter the pace or scale of new residential development.

Proposed measures to protect or conserve energy and natural resources are:

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The proposed changes would result in no direct negative impacts, and are unlikely to result in indirect or cumulative impacts related to environmentally sensitive areas or areas designated for governmental protection. The eligible locations for lodging uses would not be significantly altered by the proposal, and the proposal does not alter any procedures or regulations related to natural environment protections. The proposed changes are not expected to alter the pace or scale of new residential, and would not alter allowances for new development that could otherwise occur in or near environmentally sensitive areas under existing regulations.

Proposed measures to protect such resources or to avoid or reduce impacts are:
None proposed.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed changes would continue to allow land uses compatible with the Comprehensive Plan. Bed and breakfasts are currently allowed as an accessory use in single-family and multi-family zones under existing regulations and established bed and breakfasts will continue to be allowed under the proposal. The proposal creates a new category of lodging use, short-term rentals, which is currently not regulated or otherwise addressed in the land use code, and establishes requirements and limitations on the use that are not in place today, including a rental limit of 90-nights per year for units that are not the primary residence of the owner. As the current Shoreline Master Program does not allow lodging use over water, short-term rentals would not be allowed over water. Depending on the shoreline environment, short-term rentals may be allowed within the shoreline overlay district where residential and lodging uses are allowed on the dryland portion of waterfront lots and on upland lots. The proposed changes are not expected to alter the pace or scale of new residential development.

Proposed measures to avoid or reduce shoreline and land use impacts are:
None are proposed. Development above SEPA thresholds will continue to be reviewed on a project-specific basis and any land use related impacts identified and mitigated as part of the project's SEPA decision. Applicable regulations, including the Land Use Code and Shoreline Master Program, are anticipated to adequately mitigate any impacts.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The proposed changes would result in no direct impacts and are unlikely to result in indirect or cumulative negative impacts related to transportation or public services/utilities. The proposed changes are not expected to alter the pace or scale of new residential development.
