The purpose of the Court Administrator and Court Support Services program is to provide administrative controls, develop and provide strategic direction, establish structure and provide a consistent approach for decision making, and provide policy and program development.

2002 Proposed Program Changes

There are no program changes from the 2002 Endorsed Budget to the 2002 Proposed Budget.

2002 Adopted Program Changes

Due to the combined impact of the region's economic downturn and the passage of I-747, reduce the Court Administrator and Court Support Services program budget by \$10,621 in 2002. This represents a decrease in the printing and work-study budgets of the program.

Court Operations

Purpose Statement

The purpose of the Court Operations line of business is to provide resolution of alleged violations of the Seattle Municipal Code and enforcement of court orders for all users of court services in a fair, accessible, and timely manner.

Key Performance Targets

- Sustain recent increases in compliance rates for time-payments of Court-ordered fines at 83%.
- Increase the rate of compliance with Court-ordered probation requirements by 3 percentage points from the existing rate of 59%.
- Sustain recent reductions in the percent of Court intake hearings for which defendants fail to appear. Recent efforts have reduced the failure to appear rate from 47% to 29%.

Court Operations: Court Compliance

Purpose Statement

The purpose of the Court Compliance program is to help defendants understand the Court's expectations and to assist them in successfully complying with court orders.

2002 Proposed Program Changes

Transfer \$177,253 to the Court Compliance Program to fund community, in-custody, and Court re-licensing programs. Court Compliance coordinates these programs in order to help individuals with suspended driver's licenses fulfill their obligations to all jurisdictions (including Seattle Municipal Court) and reinstate their driving privileges, thereby reducing the number of Driving While License Suspended charges in the City of Seattle.

Add \$68,000 and 1.0 FTE Probation Counselor II in 2002 to the Court Compliance Program for an additional Probation Counselor in the Mental Health Court (MHC). This position will join two other Mental Health Court Probation Counselors to provide intensive monitoring of defendants' compliance with MHC Conditions of Sentence, which include a mental health treatment plan (including medication) and coordination with case managers and ancillary resources (especially housing). Associated funding and position authority were included in the 2002 Endorsed Budget.

2002 Adopted Program Changes

Due to the combined impact of the region's economic downturn and the passage of I-747, reduce the Court Compliance program budget by \$221,334 in 2002. This reduction holds four positions vacant for a portion of 2002 and decreases a number of administrative and technology-related line items in the program, such as training and computer replacement.

Court Operations: Court Proceedings

Purpose Statement

The purpose of the Court Proceedings program is to hold hearings and address all legal requirements for defendants and others who come before the Court. Some proceedings are held in a formal courtroom and others in magistrate offices with the goal of providing timely resolution of alleged violations of City ordinances and misdemeanor crimes committed within the City of Seattle limits.

2002 Proposed Program Changes

There are no program changes from the 2002 Endorsed Budget to the 2002 Proposed Budget.

2002 Adopted Program Changes

Due to the combined impact of the region's economic downturn and the passage of I-747, reduce the Court Proceedings program budget by \$580,174 and eliminate 1.0 FTE Court Clerk, 1.0 FTE Court Clerk Supervisor, and 1.0 FTE Bailiff in 2002. This reduction action cuts savings associated with maintaining a vacant judicial position and eliminates associated courtroom staffing and incidental expenditures such as judicial training. In addition, the reduction freezes two positions in Customer Service, two in Administration, and one in Court Services as well as decreases a number of administrative and technology-related line items in the program, such as training and computer replacement.
