

WHAT'S HAPPENING WITH HALA



Preservation Round Table

Over 55 property owners and multi-family building brokers gathered on June 13 at City Hall to provide feedback about tools to preserve existing private market affordable housing. The group participated in a roundtable discussions on programs that would reserve affordable homes including:

- low cost financing for rehabilitation,
- a preservation tax exemption,
- city-financed purchase of buildings and
- notice of sale requirements for buildings being listed.

In general property owners were interested in preservation strategies, provided there was an adequate incentive for participation to offset the cost of lowering rents to levels affordable levels. Building owners also stressed they would be more likely to participate if the city provided technical assistance to meet program requirements. The Office of Housing plans to present their preservation strategy to City Council in September. Stay tuned for more on that.

What we heard from you about Fair Chance Housing Legislation

What is Fair Chance Housing (FCH)?

FCH is legislation aimed at increasing access to housing for people with a criminal history. An estimated one in every three adults in the United States has a criminal record, and nearly half of all children in the U.S. have one parent with a criminal record. Due to a rise in the use of criminal background checks during the tenant screening process, people with arrest and conviction records face major barriers to housing. Fair Chance Housing legislation could lessen some of the barriers people face.
