COVID-19 Gig Worker Premium Pay Ordinance Fact Sheet	COVID-19 ragaa qajeelcha mootummaa kanfaltii hojattoota Gig agarsiisu
The Gig Worker Premium Pay Ordinance requires covered Food Delivery Network Companies to pay gig workers additional compensation, called “premium pay,” for delivery orders with pick-up or drop-off points in Seattle. Premium pay is in addition to compensation, bonuses, commissions, and tips owed to a gig worker for services provided. This law is effective from 8:30 PM on June 26, 2020 until the end of the COVID-19 civil emergency.	Qajeelchi mootummaa kanfaltii hojattoota Gig kubbaanniyyaawwan neetworkii nyaata dhiyeessan hojattoota Gigitif beenyaa dabalataa “premium pay” jedhamu ajaja qaqqabsiisuu Siyatil keessatti fudhatamu fi buufamuf akka kaffalan ni gaafata. Kanfalttiin kun beenyaa/compensation, dabalata, bu’aa daldalaa, fi qaccee ykn tiippii tajaajila hojattoota giigi tiif kennname irratti kan dabalamuudha. Seerri kun waxxabajii 26, 2020 galgala sa’ a 8:30 eegalee hanga qajeelfamni yeroo hatattamaa COVID – 19 raawwatutti hojii irra ni oola.
Which companies are covered by this law? This law applies to Food Delivery Network Companies (FDNCs), which include companies that offer prearranged food, beverage, or grocery delivery services for compensation using an online or cellphone application to connect customers with delivery workers (“gig workers”). To be covered by this law, the FDNC must hire 250 or more gig workers worldwide.	Kubbaanniyyoota kamtu seera kanaan qabatamee? Seerri kun Neetworkii kubbaanniyyoota nyaata dhiyeesan (FDNCs), kan akka kubbaanniyyoota nyyata dursee qophaa’ee, dhugaatii, ykn kanfaltii tajaajila groosarii dhiyyeessuuf onlaayin ykn iyyannaa moobaayilaatiif fayyadamuun mamiltoota hojattoota dhiyeessan (hojattoota gig) wajjin kan walqunnamsiisan ni dabalata. Seera kanatti hammatamuuf, FDNC iin dirqamaan addugnaa hunda irraa hojattoota gig 250 ykn isa ol qaxxarutu irra jira.
Which gig workers are covered by this law? This law applies to gig workers who accept offers of delivery services for compensation from a covered FDNC. To be covered by this law, the gig worker must make a delivery with a drop-off or pick-up point in Seattle.	Hojattoota gig kamtu seera kanaan hammatamee jiraa? Seerri kun hojattoota gig kan tajaajila buussuu/delivery tiif kanfaltiidhaaf FDNC hammatamee irraa wanta dhiyaate kan fudhatan ni ilaallata. Seera kanaan hammatamuudhaaf, hojjataan gig wanta qaqqabsiisu/delivery taassisu dirqamaan bakkee Siyatilitti argamu irraa kaasuu ykn buusuu qaba.
How much premium pay is owed? A gig worker must receive at least \$2.50 per order in premium pay, where there is either a pick-up or drop-off in Seattle.	Ammamtuu kanfalamaa? Hojjataan gig dirqamaan kanfaltii ajaja tokkoo irraa bakkeewwan Siyatil bakkee irraa kaafamuu fi itti bufatamu irratti \$ 2.50 argachuu qaba.
