Minh Chau Le explained the proposal for a storefront blade sign. Exhibits reviewed included a photo of the existing sign, color and materials information, and attachment details. Guidelines that applied to this application included 13 Signs: a and b.

Rachel Wilcox said the signage will be installed in same location as the existing sign. She said she would double check that the edge of the outer ring is black.

Joe Herrin said the edge should be finished with the preferred color being black.

Tommy Patrick agreed that the edge should be finished.

Action: Joe Herron made a motion to approve the application as presented with edge finished and the preferred edge color being black.
