# PATIO ELEVATION

## PIZZA AND PASTA BAR Checklist items

1. Proposal is for one sign two sided placed on north side at patio entrance. Dimensions 18" H x 24" W, 3/8" thickness and made of weatherproof polycarbonate.  
Awning is pre-existing, retractable and water resistant canvas.  
Hanging baskets are seasonal, part of the proposal and pots are made of fiber and 16" diameter and 10" high, see elevation. Hanging baskets will be attached to the existing iron work via wire steel hooks and secured with zip ties and will not impede the pedestrian walkway.
2. See enclosed patio elevation drawing. Brick wall enclosure dimensions 1'8" H, 24' W x 9'3" D. Existing Patio dimensions 7'8", and 6' from top of brick wall to top of structure. Signage height clearance 4'8" and basket clearance 4' 2.5"H from bottom to alley walkway.  
Alleyway is 15'8" W.
3. See photo of existing awning.
4. Hanging baskets are brown fiber pots filled with seasonal flowers of various colors.
5. Name of applicant is Babak Ziraknejad

4-way cassette features 3 receptacles which allow the unit to receive belts from up to 3 additional retractable belt stanchions




#### Belt Lock
