

CITY OF SEATTLE 2016 STATE LEGISLATIVE BULLETIN

February 15, 2016 Number 5

The City of Seattle is committed to being a safe, vibrant, interconnected, and affordable city.

Week Overview

February 9th was the halfway point for the 60-day session and the fiscal committee cut-off date. This means fiscal committees (e.g., House Finance, House Appropriations, House and Senate Transportation, and Senate Ways & Means) had to vote bills out by that date in order for those bills to proceed this session. Any bill deemed NTIB (necessary to implement the budget) are exempt from these cut-off deadlines. The next deadline for legislation is February 17th. This is the day by which the chamber of origin must pass its own bills off the floor so that they may proceed to the opposite chamber for consideration.

Also on February 9th, I-732, the carbon tax initiative to the legislature, had a hearing in the Senate Energy, Environment & Telecommunications Committee. The legislature has a number of options for addressing this initiative. They can do nothing and send it to the voters for a November 2016 vote. They can pass it and it becomes law. Or they can amend it and send an alternative to the ballot. If they were to pass an amended version then both the original and the alternative would be on the ballot in November 2016.

On Wednesday, February 10th, the Senate brought forward <u>SB 6443</u> for a floor vote. This bill would have repealed a new rule allowing transgender people to use restrooms and other facilities of the gender with which they identify. After three Senate Republicans crossed the aisle and voted with Senate Democrats, the bill was defeated by a 25-24 vote.

Friday, February 12th, the Senate addressed Sen. Roach's(R) <u>SJR 8211</u>, which requires a two-third supermajority vote by each chamber to approve new taxes in Washington State. The legislation failed, by a vote of 26-23, to receive the required two-thirds majority (33 votes) to pass.

Priority Areas

Safety Net and Housing

Preservation Tax Exemption

SB 6239 (Sen. Fain-R), which provides a property tax exemption for the preservation of affordable housing, was passed out of the Senate Ways and Means Committee on Tuesday, February 9th. On February 12th, the Senate Rules Committee placed the bill on second reading. The City supports this legislation.

Tenant Protections

SB 6413/HB 2811, sponsored by Sen. Mullet (D) and Rep. Walkinshaw (D), respectively, would modify the residential landlord-tenant act to require a landlord to notify a prospective tenant if they will accept a comprehensive reusable tenant screening report prior to charging that prospective tenant for a background check or screening report. On Monday, February 15th, the Senate passed SB 6413, 46-2. The House version of the bill is in Rules. The City supports this legislation.

<u>HB 1565</u> (Rep. Ormsby-D; companion bill <u>SB 5378</u>), prohibits a person from discriminating against a tenant based on his or her source of income. This bill remains in the House Rules Committee awaiting further consideration. The City supports this legislation.

Homeless Housing

<u>HB 2929</u>, providing temporary homeless housing, passed the House unanimously on February 11th. That same day, <u>2EHB 2086</u>, with the intent of making it easier for religious establishments to provide housing for the homeless passed the House (53-43). The City supports these bills.

Youth Mental Health

Rep. Kagi's (D) bill <u>SHB 2439</u>, increasing access to adequate and appropriate mental health services for children and youth, was reported out of the House Appropriations Committee on Tuesday, February 9th, and referred to House Rules. Sen. Darneille's (D) <u>2SSB 6494</u> (the companion to 2439), moved out of Senate Rules Committee and was placed on the floor calendar for a second reading on February 12th. The City supports this legislation.

Repeal of I-200

<u>HB 2822</u>, introduced by Rep Santos (D), which sought to repeal Initiative 200, which was passed in 1998 and prohibits affirmative action hiring for public employers, in public education and for contracting services hired by public employers failed to move out of the House Capital Budget Committee by the February 9th deadline. The City supported this legislation.

Birth Control Access

SHB 2465 (Rep. Robinson-D), passed the House with a vote of 91-6. The legislation allows insurance carriers and Medicaid to reimburse for a one-year supply of birth control. 2SHB 2681 (Rep. Stambaugh-R), allowing pharmacists to prescribe and dispense birth control, passed the House 67-30.

Statewide Rape Kit Tracking System

<u>SHB 2530</u> (Rep. Orwall-D), sets up a statewide system to track all rape kits. The bill passed House Appropriations on February 9th, and has been referred to the Rules Committee. In anticipation of it passing the House by February 17th, this bill has already been scheduled for a hearing in the Senate Law and Justice Committee on February 18th. The City supports this legislation.

Public Safety and Government Operations

Post-incarceration aid

Rep. Pettigrew's (D) <u>HB 2791</u>, which authorizes the creation of a statewide council to help address and promote successful reentry of offenders after incarceration back into the public. The bill was moved out of the House Appropriations Committee on February 9th, and passed the House on February 15th by a 94-3 vote. The City supports this legislation

Marijuana

<u>HB 2494</u> (Rep. Tarleton-D), which would seek to align marijuana possession penalties more closely with alcohol possession penalties, passed the House on February 15th by a 73-25 vote.

<u>HB 2368</u> (Rep. Hurst-D), which would allow a 2-year pilot program in Seattle for marijuana delivery services, was placed on second reading in Rules and awaits floor action. The City supports both pieces of legislation.

Pensions

On Thursday, February 11th, the House voted 96-1 to pass <u>HB 2648</u> (Rep. Fey-D), which would expand investment opportunities for the Cities of Seattle, Tacoma and Spokane. The bill is scheduled for a hearing in Senate Government Operations on February 18th. The Senate companion bill, SB 6170 (Sen. Roach-R), moved to the Senate floor calendar on February 12th. The City supports this legislation.

Public Records Requests

HB 2576 (Rep. McBride-D), was referred to House Rules on February 9th, and is awaiting consideration. This legislation would seek to, among other things, authorize a local agency to adopt a policy on the amount of time it devotes to public records requests provided certain documents are publically available and meet certain other criteria. The bill was amended to remove a requirement that would impose fees on requests made for commercial purposes. The City supports this legislation.

Gun Safety

Rep. Parker's (R) legislation (<u>HB 2823</u>), which aims at reducing school shootings by encouraging students to provide tips to law enforcement, passed out of the House Appropriations Committee 28-1 on February 9th, and was pulled from House Rules on February 12th.

Deadly Force

<u>HB 2908</u> (Rep. Ryu-D), relating to standards around use of deadly force and creating a task force to look at community policing standards was pulled from House Rules on February 11th.

Education

McCleary

The McCleary decision requiring that the state fully fund basic education by 2018 continues to be a source of contention in the legislature, with some members of House leadership indicating that talks had not yet begun between Republicans and Democrats on how to address it. On February 8th, Rep. Pat Sullivan (D) indicated talks would begin only after the Senate passed a legislative proposal (the House already passed their proposal last month--ESHB 2366 by Rep Lytton-D). That bill has been referred to the Senate Early Learning Committee and is scheduled for a hearing on February 18th.

The following day, the Senate Ways & Means Committee adopted a new "McCleary plan" bill (2SSB 6195, Sen. Rivers-R). The Senate legislation aims to address the court holding that using local levy funds for K-12 basic education expenses is unconstitutional. While both bills are very similar, importantly, they differ on the legislative deadline to identify a funding source to replace local levy dollars currently funding those services. The House bill directs the legislature to take action by 2017 while the Senate bill requires action by 2018.

Student Homelessness

<u>HB 1682</u> (Rep. Fey-D), passed the House on February 10th by a vote of 68-28. This bill seeks to improve educational outcomes for homeless students through increased in-school guidance supports, housing stability, and identification services.

Early Learning

<u>SHB 2716</u> (Rep. Senn-D), aimed at providing vulnerable children with 12 months of early learning, was passed out of House on a 90-6 vote on February 12th.

Transportation

Oil Transportation Safety

On Friday February 12th, <u>HB 2575</u>, prime sponsored by Rep. Farrell (D), passed the House on a 93-2 vote. The legislation directs the Department of Ecology to contract for an update to the State's response capacity to chemical, biological, radiological, nuclear and explosive agents by June 2017.

Environment

Solar Incentives

SHB 2346 (Rep. Morris-D), regarding the solar production incentive, passed the House Appropriations Committee on February 9th by a 27-5 vote and moved to Rules. There remain a number of concerns with the bill, including a too-low rate for community solar at 18-cents, and a provision which would allow the program administrator (WSU Energy) to no longer accept applications for the incentive if a utility nears its tax credit limit. The City supports this legislation and is working to address these concerns.

Carbon Reductions

ESSB 5735 (Rep. Ericksen-R), which addresses providing incentives for carbon reduction investments, was moved from the Senate Rules Committee to the floor. This bill makes significant changes to I-937 by allowing certain new investments in carbon reduction to count towards a utility's renewable target. There is speculation that this legislation may be viewed as a potential I-732 alternative. The City opposes this legislation.

Growth Management Act

<u>SB 6426</u>, prime sponsored by Sen. Conway (D), allows schools to be located outside urban growth boundaries defined by the GMA. This bill passed the Senate Government Operations Committee and was placed on second reading in Senate Rules. The city is concerned that this bill seeks to undermine the GMA's intention to contain urban growth, and thus, opposes the legislation.

Paint Stewardship Program

ESHB 1571 (Rep. Peterson-D), with the intent of reducing pollution from improper paint disposal, passed the House with a 51-46 vote on February 10th, and was referred to the Senate Energy and Environment Committee.

Looking Ahead

The Legislature will soon be turning more attention to the 2016 supplemental budget following the revenue forecast release scheduled for February 17th. The House will release its supplemental proposal first, followed by the Senate. House Leadership has stated they will prioritize closing the opportunity gap, securing equal pay, and reducing homelessness in their budget.

Again, February 17th, is House of Origin cut-off. Action then moves back to the policy committees to hear bills passed from the opposite chamber.

We are looking forward to hosting Seattle City Councilmembers in Olympia on Tuesday, February 23rd, for a Lobby Day.
