### Week Overview

Friday, February 2<sup>nd</sup>, marked the Legislature's first, self-imposed cutoff deadline. All bills must have passed out of their house of origin policy committee by this day in order to remain viable through session. Throughout the week, most committees focused on executive sessions to vote bills out of committee. The 4,100-plus active bill list was significantly reduced. Legislators' attention now shifts to budget-related matters. Bills that are to remain alive will need to pass out of their fiscal committees by February 6<sup>th</sup>. It is worth noting that despite these important cutoff deadlines, bills considered "necessary to implement the budget" (NTIB) are exempt from these deadlines. So, though a bill may not have met its deadline, no bill is truly dead until session concludes.

### Priority Areas

#### **Homelessness and Housing**

*Affordable Housing Development:* [HB 1797](#), sponsored by Rep. McBride, allows cities to apply for a one-time remittance of 4.37 percent of the state sales and use tax on public purchases for affordable housing development or public infrastructure to support such development, allows the governing body of a county with a population over 1.5 million and the cities within such county to authorize the existing 0.1 percent local sales and use tax used for mental health services and affordable housing, and allows revenue from the local real estate excise tax to be used for affordable housing development through 2022, so long as other local capital projects have adequate funding. The bill was placed on second reading by Rules Committee on January 16<sup>th</sup>.

*Affordable Housing Investments:* [HB 2437](#), sponsored by Rep. Robinson, authorizes the governing body of a county to impose a local sales tax, credited against the state sales tax, for affordable or supportive housing. HB 2437 received a public hearing in the House Committee on Finance on January 16<sup>th</sup>. The bill is scheduled for executive session on February 5<sup>th</sup>.

*Affordable Housing Tax Credit:* [SB 6532](#), sponsored by Sen. Mullet, establishes the Washington Affordable Housing Tax Credit program authorizing state credits for low-income housing developments and authorizes \$7 million in annual Washington Affordable Housing tax credits with respect to taxes imposed for the insurance premiums tax or the business and occupation (B&O) tax. The bill received a public hearing in the Senate Committee on Financial Institutions and Insurance on January 30<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and it was referred to the Senate Committee

on Ways and Means on February 2<sup>nd</sup>. Rep. McBride introduced a similar bill, [HB 2913](#), and the bill received a public hearing in the House Committee on Community Development, Housing, and Tribal Affairs on January 30<sup>th</sup>, and no executive action was taken before the policy cutoff deadline.

*Condominium Bylaws:* [SB 6001](#), sponsored by Sen. Keiser, provides an alternative process for acquiring and counting votes to amend condominium bylaws, requires notice of a vote to owners who fail to vote, and subtracts the number of unreturned ballots from the total number of unit owners before applying the minimum percentage required to amend. The bill received a public hearing in the Senate Committee on Law and Justice on January 25<sup>th</sup> and was amended on February 1<sup>st</sup>. It was passed to the Senate Rules Committee on February 2<sup>nd</sup>.

*Facilities Financing:* [HB 2364/SB 6371](#), sponsored by Rep. Ryu and Sen. Mullet, concerns facilities financing by the housing finance commission (HFC). The bill increases the Housing Finance Commission's debt limit from \$6 billion to \$8 billion and expands the organizations eligible for lower-cost financing through the HFC's Nonprofit Facilities Program. HB 2364 was voted out of the House Committee on Community Development, Housing and Tribal Affairs on January 16<sup>th</sup>, heard in the House Capital Budget Committee on January 30<sup>th</sup>, and executive action was taken on February 2<sup>nd</sup>. It is scheduled for executive session in the House Committee on Capital Budget on February 5<sup>th</sup>. SB 6371 passed to the Rules Committee for second reading on January 26<sup>th</sup>.

*Housing Opportunity Zones:* [SB 6417](#), sponsored by Sen. Palumbo, creates a voluntary pilot program for cities and counties to establish housing opportunity zones in order to enable and encourage compact and efficient development within a one-half mile distance around transit facilities. The bill was heard in the Senate Committee on Local Government on January 30<sup>th</sup>. The bill was amended and referred to Ways and Means on February 2<sup>nd</sup>. Rep. Ryu sponsored [HB 2711](#), which is a companion to the SB 6417. The bill received a public hearing in the House Committee on Community Development, Housing and Tribal Affairs on January 18<sup>th</sup>, but no executive action was taken before the policy cutoff deadline.

*Preventing Fires:* [HB 2864/ SB 6473](#), sponsored by Sen. Lias and Rep. Eslick, directs the director of fire (Director) protection to investigate ways to prevent fire deaths in rental dwellings and requires the Director to convene a task force of various stakeholders, allow for public comment at task force meetings, and provide a report on the task force's findings and recommendations to the Governor and Legislature. SHB 2864 received a public hearing in the House Committee on Local Government, the bill was amended on January 30<sup>th</sup>, and referred to the Rules Committee on February 1<sup>st</sup>. SSB 6473 received a public hearing in the Senate Committee on Financial Institutions and Insurance, amended on January 23<sup>rd</sup>, and referred to the Ways and Means Committee on January 24<sup>th</sup>.

*Property Tax Exemptions:* [HB 1532/SB 5143](#), sponsored by Rep. Lytton and Sen. Zeiger, clarifies the property tax exemption for nonprofit homeownership development by specifying that land that is to be leased for 99 years or life to a low-income household qualifies for the exemption and specifies that the lease of the exempted land to a low-income household terminates the property tax exemption. HB 1532 passed out of the House on February 1<sup>st</sup> with an 89-5 vote count. ESSB 5143, passed out of the Senate on January 24<sup>th</sup> with a 41-8 vote count and has been referred to the House Finance Committee.

[SB 6242](#), sponsored by Sen. Braun, authorizes a \$100,000 assessed value homestead exemption for state property taxes, subject to approval by the voters of a constitutional amendment. It received a public hearing in the Senate Committee on Ways and Means on January 25<sup>th</sup>.

[SB 6251](#), sponsored by Sen. Dhingra, modifies the qualifying income thresholds for the property tax exemption and deferral programs for low-income senior citizens, individuals with disabilities, and veterans, beginning in calendar year 2020. It received a public hearing in the Senate Committee on Ways and Means on January 25<sup>th</sup>.

[HB 2597/SB 6314](#), sponsored by Sen. Dhingra and Rep. Sullivan, extends the existing state property tax exemption for residences of senior citizens and disabled persons to local regular property taxes. HB 2597 received a public hearing in the House Committee on Finance on January 23<sup>rd</sup> and is scheduled for executive session on February 5<sup>th</sup>. SB 6314 was amended on February 1<sup>st</sup> in the Senate Committee on Local Government and referred to Senate Ways and Means committee. The bill is scheduled for public hearing on February 5<sup>th</sup>.

[SB 6361](#), sponsored by Sen. Billig, allows the governing authority of certain cities to adopt a local property tax exemption program, under which qualifying new construction is exempt from local property tax for ten years. It received a public hearing in the Senate Committee on Economic Development and International Trade on January 25<sup>th</sup>. The bill was amended on February 1<sup>st</sup> and passed to the Rules Committee for second reading on February 2<sup>nd</sup>.

[SJR 8212](#), sponsored by Sen. Braun, amends the Constitution to authorize the creation of a homestead exemption for state property taxes. It received a public hearing in the Senate Committee on Ways and Means on January 25<sup>th</sup>.

*Homeless Housing Surcharge:* [HB 1570](#), sponsored by Rep. Macri, makes the temporary \$40 local homeless housing and assistance surcharge permanent, allows counties to charge and retain an additional surcharge for homeless housing and assistance, allows additional homeless housing and assistance surcharges imposed by a county to be used to pay off general obligation bonds issued by the county for homeless housing and assistance, changes the Home Security Fund from an appropriated account to a nonappropriated account, and creates new and updated reporting requirements and studies for certain homeless assistance programs. The bill received a public hearing in the House Committee on Appropriations on January 17<sup>th</sup> and moved out of the committee on January 22<sup>nd</sup>. It has been placed on second reading.

*Notice of Termination of Tenancies:* [HB 2040/SB 5408](#), sponsored by Rep. Frame and Sen. Cleveland, extends the required notice period for termination of a periodic tenancy. HB 2040 received a public hearing in the House Committee on Judiciary on January 10<sup>th</sup>. SB 5408 was placed on second reading by the Rules Committee on January 25<sup>th</sup>.

*Real Estate Excise Tax Exemption:* [HB 2444](#), sponsored by Rep. Slatter, provides a real estate excise tax exemption for the transfer of a qualified low-income housing development or controlling interest in a qualified low-income housing development. It received a public hearing in the House Committee on Finance on January 16<sup>th</sup> and executive action was taken on February 2<sup>nd</sup>. It was referred to the Rules Committee.

*REET:* [HB 2876 /SB 6490](#), sponsored by Sen. Takko, removes a provision requiring voter approval before a county choosing to plan under the Growth Management Act (GMA) and cities within those counties may impose additional real estate excise taxes (REET II) and allows initiatives and referenda to repeal REET II imposed by counties and cities choosing to plan under the GMA. SB 6490 received

a public hearing in the Senate Committee on Local Government on January 23<sup>rd</sup> and moved out of committee on January 25<sup>th</sup>. The bill has been passed to the Rules Committee for second reading. HB 2876 received a public hearing in the House Committee on Finance on January 30<sup>th</sup>.

[HB 2875/SB 6557](#) sponsored by Sen. Mullet and Rep. McBride, exempts the building and sale of self-help housing by an affordable homeownership facilitator from retail sales and use tax and the real estate excise tax (REET). HB 2875 received a public hearing in the House Committee on Finance on January 30<sup>th</sup> and is scheduled for executive action on February 5<sup>th</sup>. SB 6557 received a public hearing in the Senate Committee on Financial Institutions and Insurance on January 30<sup>th</sup>, the bill was passed out of committee on February 1<sup>st</sup> and referred to the Senate Committee on Ways and Means.

*Restrictive Covenants:* [SB 6379/SB 2674](#), sponsored by Sen. Fain, clarifies that a local government wishing to remove a restrictive covenant from land it owns need not first hold a public hearing unless the restrictive covenant is recorded. SB 6379 received a public hearing and executive action in the Senate Committee on Local Government on January 23<sup>rd</sup> and was passed to the Rules Committee on January 25<sup>th</sup>. The bill has been placed on the second reading consent calendar. HB 2674 received a public hearing in the House Committee on Local Government on January 16<sup>th</sup> and passed out of committee on January 30<sup>th</sup>. The bill was then referred to the Rules Committee on February 1<sup>st</sup>.

*Single Family Housing:* [HB 2480](#), sponsored by Rep. McBride, allows a county or city to establish a program to exempt property taxes for up to 12 years on portions of single family properties that provide affordable housing to low income tenants. The bill received a public hearing in the House Committee on Community Development, Housing and Tribal Affairs on January 23<sup>rd</sup> and passed out of committee on January 25<sup>th</sup>. The bill has been referred to Finance.

*Source of Income:* [SB 5407/HB 1633](#), sponsored by Sen. Frock and Rep. Riccelli, concerns the preservation of housing options for tenants and prohibits landlords from refusing to rent property, expelling tenants, discriminating, or discouraging a rental to a tenant based on their source of income. The bill also creates a landlord mitigation program in the Department of Commerce allowing landlords to seek reimbursement for repairs of documented damages to qualifying rental units. SB 5407 received a public hearing in the Senate Committee on Financial Institutions and Insurance on January 11<sup>th</sup> and an amended bill was passed out of committee on January 25<sup>th</sup>. The bill is scheduled for public hearing in the Senate Committee on Ways and Means on February 5<sup>th</sup>. HB 1633 has been referred to the House Committee on Judiciary. Rep. Riccelli also introduced an additional source of income bill, [HB 2578](#), which received a public hearing in the House Committee on Judiciary on January 23<sup>rd</sup> and executive action was taken on February 1<sup>st</sup>. The bill was referred to the House Committee on Appropriations on February 2<sup>nd</sup>.

*Surplus Property:* [HB 2382](#), sponsored by Rep. Ryu, promotes the use of surplus public property for public benefit. The substitute bill has been voted out of the House Committee on Community Development, Housing and Tribal Affairs as well as Capital Budget. It has been scheduled for a public hearing in the House Committee on Transportation on February 5<sup>th</sup> and an executive session on February 6<sup>th</sup>.

Inactive

*Accessory Dwelling Units:* [HB 2503](#), sponsored by Rep. Vick, allows certain local governments to allow development and placement of accessory apartments within or outside Urban Growth Areas. It

received a public hearing in the House Committee on Community Development, Housing and Tribal Affairs on January 23<sup>rd</sup>. The bill was scheduled for executive session on January 30<sup>th</sup>, January 31<sup>st</sup>, and February 1<sup>st</sup>, but no action was taken.

*Density Plans:* [SB 6077](#), sponsored by Sen. Palumbo, concerns minimum density standards for comprehensive plans adopted by cities and sets a minimum density standard of no less than six dwelling units per acre for areas designated as residential in an urban growth area. SB 6077 received a public hearing in the Senate Committee on Local Government on January 11<sup>th</sup>.

*Religious Organization Housing:* [SB 6555](#), sponsored by Sen. Padden, prohibits counties, cities, and towns from adopting ordinances that require modifications to structures within buildings that were built in accordance with building codes at the time of construction and are owned by a religious organization that provide temporary housing for the homeless, requires the liberal construction of state building and energy codes to effectuate the policy of providing temporary housing for the homeless by religious organizations and to allow for shelter for individuals, and requires the installation of smoke detectors, upon request by a fire code official, in buildings owned by religious organizations that provide temporary housing for the homeless. The bill received a public hearing in the Senate Committee on Human Services and Corrections on January 29<sup>th</sup>.

*Rent Regulation:* [HB 2583/SB 6400](#), sponsored by Rep. Macri and Sen. Saldaña, repeals provisions that prohibit towns, cities, and counties from enacting, maintaining, or enforcing ordinances which regulate the amount of rent to be charged for single-family or multiple-unit residential rental structures. HB 2583 received a public hearing in the House Committee on Judiciary on January 23<sup>rd</sup>. SB 6400 received a public hearing in the Senate Committee on Financial Institutions and Insurance on January 30<sup>th</sup>.

## **Safety Net and Civil Rights**

*Ban the Box/Fair Chance Act:* The Washington Fair Chance Act, [SB 6110](#) and [HB 1298](#), sponsored by Sen. Saldaña and Rep. Ortiz-Self, prohibits employers from making inquiries related to criminal records until after initially determining the applicant is qualified for the position. It also prohibits ads or policies excluding applicants with criminal records and authorizes the attorney general to enforce the Act and provides penalties. SB 6110 received a public hearing in the Senate Committee on Labor and Commerce on January 10<sup>th</sup> and passed out of committee on January 22<sup>nd</sup>. It received a public hearing in the Senate Committee on Ways and Means on January 30<sup>th</sup>. HB 1298 passed out of the House Committee on Labor and Workplace Standards on January 9<sup>th</sup> and has been placed on second reading.

*Civil Service Qualifications:* [SB 6145](#), sponsored by Sen. Saldaña, changes the civil service qualification for police officers, fire departments, and county sheriff departments by expanding who can apply for a position to include a lawful permanent resident. SB 6145 received a public in the Senate Committee on Labor and Commerce on January 18<sup>th</sup> and passed out of committee on January 22<sup>nd</sup>. It has been passed to the Rules Committee for second reading.

*Equal Pay:* The Equal Pay Act, [HB 1506](#) and [SB 5140](#), sponsored by Rep. Senn and Sen. Cleveland, prohibits discrimination in providing employment opportunities based on gender and prohibits retaliation for certain workplace discussions about wages and other matters. HB 1506 was voted out of the House on January 17<sup>th</sup> and has been referred to the Senate Committee on Labor and Commerce.

SB 5140 received a public hearing in the Senate Committee on Labor and Commerce on January 10<sup>th</sup> and passed out of committee on January 22<sup>nd</sup>. It has been passed to the Rules Committee for second reading.

*Families in Need of Services:* [SB 6467](#), sponsored by Sen. Darneille, creates a families in need of services (FINS) petition model that replaces and merges the at-risk youth (ARY) and child in need of services (CHINS) petition model, while expanding the definition of petitioner to include a youth, parent, or other suitable adult. The bill received a public hearing in the Senate Committee on Human Services and Corrections on January 22<sup>nd</sup>, amended and passed out of committee on January 30<sup>th</sup>. The bill was referred to Ways and Means on February 1<sup>st</sup>.

*HEN Entitlement:* [SB 6116](#), sponsored by Sen. Darneille, provides that the Essential Needs and Housing Support Program (HEN) is an entitlement, removes a mandate that individuals who are homeless or are at substantial risk of losing stable housing receive HEN services before other eligible individuals receive services, removes language that would allow a support entity to refuse to provide HEN services to a person referred to the entity, requires the Department of Social and Health Services and Department of Commerce to conduct a study to determine the appropriate benefit amount for persons eligible to receive HEN or aged, blind, or disabled (ABD) assistance program services. The bill received a public hearing in the Senate Committee on Human Services and Corrections on January 17<sup>th</sup> and an amended bill passed out of Committee on January 24<sup>th</sup>. It has now been referred to the Senate Committee on Ways and Means.

*HEN Expansion:* [HB 2667/SB 6502](#), sponsored by Rep. Macri and Sen. Dhingra, expands eligibility for referrals to the Essential Needs and Housing Support (HEN) program to include recipients of the Aged, Blind, or Disabled cash assistance program and requires information sharing of limited recipient data between the Department of Social and Health Services, the Department of Commerce, and HEN providers. HB 2667 received a public hearing in the House Committee on Early Learning and Human Services on January 17<sup>th</sup> and was voted out on January 19<sup>th</sup>. It was referred to the House Committee on Appropriations and received a public hearing February 1<sup>st</sup>. SB 6502 received a public hearing in the Senate Committee on Human Services and Corrections on January 29<sup>th</sup> and the substitute bill was passed out of committee on January 30<sup>th</sup>. It has been referred to the Senate Committee on Ways and Means and is scheduled for a public hearing on February 5<sup>th</sup>.

*I-200 Repeal:* [SB 6406](#), sponsored by Sen. Chase, repeals the 1998 Initiative 200 (I-200) language regarding discrimination and preferential treatment in the operation of public employment, education, or contracting. The bill received a public hearing in the Senate Committee on State Government, Tribal Relations and Elections on January 26<sup>th</sup> and was passed out of committee on January 31<sup>st</sup>. The bill has been placed on second reading by the Rules Committee.

*Keep Washington Working Act:* [SB 5689/HB 1985](#), sponsored by Sen. Wellman and Rep. Ortiz-Self, establishes a statewide policy supporting Washington state's economy and immigrants' role in the workplace. The bill enacts the Keep Washington Working Act and establishes a Steering Committee, requires the Attorney General to publish model policies for limiting immigration enforcement to the fullest extent possible consistent with the law, restricts the use of state resources to assist in unconstitutional or illegal registration or surveillance programs or any other unconstitutional or illegal laws, rules, or policies targeting Washington residents on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin, and restricts agencies and other departments from using their resources or transferring or detaining an individual to federal immigration authorities absent a

proper warrant. SB 5689 was voted out of the Senate Committee on Labor and Commerce on January 17<sup>th</sup> and is scheduled for public hearing in the Senate Committee on Ways and Means on February 5<sup>th</sup>.

*Occupational Disease:* [SB 6213/HB 2633](#), sponsored by Sen. Ranker and Rep. Doglio, adds medical conditions to the presumption and extending the presumption to certain publicly employed firefighters and investigators and law enforcement. SB 6213 received a public hearing in the House Committee on Labor and Workplace Standards on January 15<sup>th</sup> and January 17<sup>th</sup>, and passed out of Committee on January 24<sup>th</sup>. It has been passed to the Rules Committee for second reading. HB 2633 received a public hearing in the House Committee on Labor and Workplace Standards on January 15<sup>th</sup> and passed out of committee on January 23<sup>rd</sup>. The bill received a public hearing in the House Committee on Appropriations on February 3<sup>rd</sup>.

*Posttraumatic Stress:* [SB 6214](#), sponsored by Sen. Conway, allows industrial insurance coverage for posttraumatic stress disorders affecting law enforcement officers and firefighters. The bill received a public hearing in the Senate Committee on Labor and Commerce on January 15<sup>th</sup> and January 17<sup>th</sup> and was then passed out of committee on January 24<sup>th</sup>. It has now been passed to the Rules Committee for second reading.

*Public Defense:* [HB 2687](#), sponsored by Rep. Frame, phases in state reimbursement of county and city public defense costs by 2028, requires the Office of Public Defense (OPD) to disburse appropriated funds, establish policies for the distribution of funds, and monitor trial-level public defense services to determine eligibility for reimbursement and repeals the county formulas for the OPD public defense services grant program. The bill received a public hearing in the House Committee on Judiciary on January 24<sup>th</sup> and executive action was taken on February 1<sup>st</sup>. It has been referred to the House Committee on Appropriations.

*Sexual Harassment:* [SB 5996](#), sponsored by Sen. Keiser, prohibits an employer from requiring an employee, as a condition of employment, to sign a nondisclosure agreement that prevents the employee from disclosing sexual harassment or sexual assault, provides that any nondisclosure agreement that has the purpose or effect of preventing an employee from disclosing or discussing sexual harassment or sexual assault is void and unenforceable, and provides that it is an unfair practice under the Washington Law Against Discrimination (WLAD) for an employer to retaliate against an employee for disclosing or discussing sexual harassment or sexual assault. The bill received a public hearing in the Senate Committee on Labor and Commerce on January 24<sup>th</sup> and the substitute bill passed out of committee on January 31<sup>st</sup>. It was passed to the Rules Committee for second reading on February 1<sup>st</sup>.

[SB 6313](#), sponsored by Sen. Keiser, provides that certain employment agreements are void and unenforceable unless they preserve the employee's right to file a sexual harassment or sexual assault complaint in a court of competent jurisdiction and with the appropriate state or federal agency. The bill received a public hearing in the Senate Committee on Labor and Commerce on January 24<sup>th</sup> and the substitute bill passed out of committee on January 31<sup>st</sup>. It was passed to the Rules Committee for second reading on February 1<sup>st</sup>.

*Voting Rights:* [HB 1800](#), sponsored by Sen. Gregerson, enacts the Washington voting rights act by establishing a state voting rights act that seeks to protect the equal opportunity for minority groups to participate in local elections, creates a cause of action and authorizes courts to order appropriate remedies for a violation of the act, including redistricting within a political subdivision and authorizes local governments to change their election system to remedy violations of the act. The substitute bill

was voted out of the House Committee on State Government, Elections and Information Technology on January 16<sup>th</sup> and has been placed on second reading by the Rules Committee.

[SB 6002](#), sponsored by Sen. Saldaña, enacts the Washington voting rights act of 2018. SB 6002 creates a state voting rights act to protect the equal opportunity for minority groups to participate in local elections and elect candidates of choice, creates a cause of action and authorizes courts to order appropriate remedies for a violation of the voting rights act, including redistricting within a political subdivision and authorizes local governments to change their election systems to remedy potential violations of the act. The bill was voted off the Senate floor with a 29 - 19 vote count. It has moved to the House for consideration where it has received a public hearing in the House Committee on State Government, Elections and Information Technology on January 26<sup>th</sup>. The bill is scheduled for executive session on February 7<sup>th</sup>.

*Wrongful Death:* [HB 2262/SB 6015](#), sponsored by Rep. Santos and Sen. Hasegawa, concerns actions for wrongful injury or death and makes a number of changes to statutes governing wrongful death and survival causes of action, including changes to the beneficiaries entitled to recoveries and the damages that may be recovered under these actions. HB 2262 received a public hearing in the House Committee on Judiciary on January 11<sup>th</sup> and executive action was taken on February 1<sup>st</sup>. The bill was referred to the House Appropriations Committee on February 2<sup>nd</sup>. SB 6015 received a public hearing on January 18<sup>th</sup> in the Senate Committee on Law and Justice and the substitute bill passed out of committee on January 25<sup>th</sup>. The bill received a public hearing in the Senate Committee on Ways and Means on January 31<sup>st</sup>.

## **Health Care**

*Opioid Treatment and Prevention:* The House version of Governor Inslee’s proposal for addressing the opioid crisis, [HB 2489](#), passed unanimously out of the House Health Care & Wellness committee last week. Among other things, the proposal would implement a “hub and spoke” system that would allow every community access to medical expertise on the issue, establish statewide access to treatment, and would make medication assisted treatment more available in the state. The House version was amended in several ways by the Health Care committee. The substitute bill retains all sections of the underlying, bill but makes several changes including:

- Removing access to the PMP for commercial health carriers;
- Expanding the scope of the nonpharmacological treatment recommendations for chronic pain to also include acute and sub-acute pain.
- Adding contingency sections for sections 2-5, in the event that HB 1388 is enacted and changes the authority of behavioral health from the DSHS to the HCA.

The House bill has been referred to Appropriations and is scheduled for a public hearing on February 5<sup>th</sup>.

The Senate version, [SB 6150](#), also passed out of its respective health care committee last week, though with a vote of 8-2. The Senate bill had two amendments that were adopted:

- An amendment from Sen Cleveland that adds a requirement for state agencies to develop a data collection plan on the number of opioid related overdoses for non-English speakers; corrects several technical issues; includes contingency sections for subsections 2-5, in the event HB1388 is enacted; and broadens the scope of nonpharmacologic treatment recommendations to include acute and sub-acute pain.



- An amendment from Sen Rivers that eliminates health carriers from the list of entities with which DOH may share PMP data.

The Senate bill is scheduled for a hearing in Ways & Means on February 5<sup>th</sup>.

*Substance Disorder Treatment:* [HB 2572](#), sponsored by Rep. Cody, prohibits state health plans, private insurance plans, and behavioral health organizations from establishing prior authorization requirements for substance use disorder treatment and mandates coverage for up to 24 hours of acute treatment and clinical stabilization services for substance use disorders. The bill received a public hearing in the House Committee on Health Care and Wellness on January 19<sup>th</sup> and executive action was taken on February 2<sup>nd</sup>. A substitute bill passed and was referred to the House Appropriations Committee where it will receive a public hearing on February 5<sup>th</sup>.

*Chemical Dependency Prevention and Outreach:* [HB 2799](#), sponsored by Rep. Kagi, allows the local sales and use tax for chemical dependency and mental health to be used for prevention and outreach programs. It received a public hearing in the House Committee on Finance on January 30<sup>th</sup> and is scheduled for executive session on February 5<sup>th</sup>.

*Market Stabilization:* While Insurance Commissioner Mike Kreisler's market stability proposal to establish a reinsurance program progressed fairly quickly through committee in each chamber, neither the House, [HB 2355](#), or Senate, [SB 6062](#), bills passed off their respective chamber floor by the end of last week, which was the deadline stated by the OIC for when the bill needed to pass the legislature in order to meet the tight timeline to apply for a federal 1332 waiver. Each bill had been amended in committee – the Senate Ways & Means committee removed the funding mechanism (a health carrier and TPA assessment) from SB 6062. The House Health Care and Wellness committee amended HB 2355 to require the reinsurance program to collect assessments on behalf of the Washington State Health Insurance Pool (WSHIP) and changed the entities subject to assessments for WSHIP to be the same as the entities subject to reinsurance assessments.

While it is getting tight to meet the timeline to apply for a federal 1332 waiver in time to affect rate filings for 2019, there is still potential interest in pursuing a reinsurance program that does not go through the 1332 process and is just run by the state. The 1332 waiver has the potential to draw down some federal funds to help implement the program, so additional funding would be needed. The reinsurance program has a cost of \$200 million per year. There are early, private discussions occurring in the Senate about different approaches that could be taken.

*Community Healthcare Workers:* [HB 2436](#), sponsored by Rep. Robinson, defines community health worker and the ten roles of community health workers. The bill received public hearing in the House Committee on Health Care and Wellness on January 16<sup>th</sup> and was substituted on January 23<sup>rd</sup> when it received executive action. The bill had a public hearing in the House Committee on Appropriations on February 3<sup>rd</sup>.

*Conversion Therapy:* [SB 5722](#), sponsored by Sen. Lias, restricts the practice of conversion therapy and makes it unprofessional conduct for a licensed health care provider to perform conversion therapy on a patient under the age of 18. SB 5722 passed out of the Senate on January 19<sup>th</sup> with a 32-16 vote count. Now in the House, it is scheduled for a public hearing in the House Committee on Health Care and Wellness on February 7<sup>th</sup>.

*Preventive Services Coverage:* [HB 1523](#), sponsored by Rep June Robinson, requires health plans to cover, with no cost sharing, all preventive services required to be covered under federal law as of December 31, 2016. HB 1523 passed out of the House on January 31<sup>st</sup> with a 56-38 vote count. It has been referred to the Senate Committee on Health and Long Term Care.

*Mental Health Field Response Team:* [HB 2892](#), sponsored by Rep. Lovick, creates the mental health field response team grant program (program), administered by the Washington Association of Sheriffs and Police Chiefs and requires the Washington State Institute for Public Policy to conduct a study on whether the program improves outcomes of interactions with persons experiencing behavioral health crises. The bill received a public hearing in the House Committee on Public Safety on January 30<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and the bill was referred to the House Committee on Appropriations where it has been scheduled for a public hearing on February 5<sup>th</sup>.

*Youth Mental Health:* [HB 2779](#) /[SSB 6485](#), sponsored by Sen. Warnick and Rep. Senn, re-establishes the Children's Mental Health Workgroup. HB 2279 received a public hearing in the House Committee on Early Learning and Human Services on January 16<sup>th</sup> and a substitute bill was passed out of committee on January 19<sup>th</sup>. The bill received a public hearing in the House Committee on Appropriations on February 1<sup>st</sup>. SB 6485 received a public hearing in the Senate Committee on Human Services and Corrections on January 30<sup>th</sup> and the substitute bill was passed on January 31<sup>st</sup>. The bill was then referred to Ways and Means.

*Behavioral Health Facilities:* [SB 6468](#), sponsored by Sen. Braun, authorizes the State Finance Committee (Committee) to issue up to \$500 million in general obligation bonds to finance community-based mental health facilities and to pay issuance and bond sale expenses and directs the Secretary of State to submit the bond authorization to a vote of the people. The bill received a public hearing in the Senate Committee on Ways and Means on January 29<sup>th</sup>.

*Outpatient Behavioral Health Facilities:* [SB 6491](#), sponsored by Sen. O'Ban, expands assisted outpatient mental health treatment (AOMHT) after April 1, 2018, to include substance use disorder treatment and renames it assisted outpatient behavioral health treatment (AOBHT), reduces eligibility criteria for AOBHT and extends and simplifies AOBHT filing processes, allows revocation to inpatient treatment for a person receiving less restrictive alternative treatment pursuant to an AOBHT petition, allows a family member, guardian, or conservator of a person who files a court petition for review of a decision to not detain the person for involuntary treatment and to request that the court require the filing of an AOBHT petition. The bill received a public hearing in the Senate Committee on Human Services and Corrections on January 29<sup>th</sup> and executive action was taken on January 30<sup>th</sup>. The bill was referred to the Senate Committee on Ways and Means and is scheduled for a public hearing on February 5<sup>th</sup>.

*Essential Coverage:* [SB 6084](#), sponsored by Sen. Cleveland, would require maintenance of minimum essential health care coverage. In other words, this bill aims to establish an individual mandate at the state level since it has been repealed at the federal level. While the original bill had language requiring individuals to have health insurance coverage, it did not include an enforcement mechanism. This is particularly challenging in Washington state because we do not have a state-level income tax. The federal individual mandate worked because if a person did not comply with the law, they would be fined via their federal income taxes. Because we don't have a state income tax, we cannot use that enforcement mechanism. In order to start working towards a solution, the bill was amended in committee to add a task force to explore individual mandate enforcement mechanisms and the

feasibility of other options to incentivize the maintenance of minimum essential coverage. The task force is to report its findings to the legislature by December 1, 2018. The bill passed out of Senate Health & Long Term Care on January 23<sup>rd</sup> with a vote of 6 yes, 3 no, and 1 without recommendation. It is currently in the Rules Committee and was made eligible to be placed on second reading last week, which means it could be pulled to the Senate floor at any time.

*Individual Market Access:* While efforts around trying to start a state level reinsurance program continue, there are also discussions around establishing some type of public option on the Exchange in Washington. [HB 2408](#), sponsored by Rep Cody, was originally introduced in an effort to address bare counties where no health insurance plans are offered. There were initially two bare counties for 2018 when health insurance carriers initially filed for 2018, though the Insurance Commissioner was able to work with plans to get plan offerings there. However, it did start the conversation of what to do in the event that no plans are offered in a county. In its original form, HB 2408 would address this issue by requiring a health carrier offering a health plan approved by the School Employees' Benefits Board (SEBB) to offer a qualified health plan (QHP) in counties where no qualified health plans are offered on the Health Benefit Exchange. It also would put in place tax credits to reduce the premiums for enrollees in the Washington Health Insurance Pool (WSHIP) in counties where there is no other individual market coverage available. The bill was amended during executive session in several ways, which are summarized well by committee staff here. The bill now does the following:

- Requires health carriers that offer plans to school employees to offer at least one silver and one gold QHP in any county in which that carrier offers a SEBB plan beginning in 2020.
- Reduces a person's WSHIP premiums based on a new income-based scale that is different than the current federal premium subsidies. Of note, while federal subsidies are only currently available for people whose income is under 400% of the federal poverty level, this new state subsidy scale would include some level of premium subsidy for people all income levels who buy in WSHIP.

In short, this bill now creates a public option starting in 2020 in any county where a health carrier offers a SEBB plan. The bill passed out of House Health Care & Wellness on February 2<sup>nd</sup> with a vote of 11 yes, 3 no, and 2 without recommendation. It has been referred to the House Committee on Appropriations and is scheduled for a public hearing on February 5<sup>th</sup>.

*LGBTQ Long-term Care:* [SB 5700](#), sponsored by Sen. Ranker, requires training for long-term care providers on the needs of the LGBTQ population. The bill was moved out of the Senate Committee on Health and Long Term Care on January 16<sup>th</sup> and has been placed on second reading by the Rules Committee.

*Medicaid Access:* [SB 6304](#)/[HB 2660](#), sponsored by Sen. Frocht and Rep. Stonier, aligns the income eligibility standards for the Apple Health for Kids program (Program) with the current federal standards and removes requirements that funds must be specifically appropriated for the Program. SB 6304 was voted out of the Senate Committee on Health and Long Term Care on January 25<sup>th</sup> and has been referred to the Ways and Means Committee. HB 2660 received a public hearing in the House Committee on Appropriations on January 24<sup>th</sup>.

*Tobacco Use Age:* [HB 1054](#)/[SB 5025](#)/[SB 6048](#), requested by the Attorney General and the Department of Health, and sponsored by Rep Harris and Sen. Kuderer, raises the age at which a person may purchase and possess cigarettes, tobacco, and vapor products from 18- to 21-years of age and requires licensed retailers to display signs stating the age restriction for purchasing tobacco or vapor products.

HB 1054 was voted out of House Finance this past week and is currently in the Rules Committee. SB 5025 received a public hearing in the Senate Committee on Labor and Commerce on February 1<sup>st</sup>. SB 6048 received a public hearing in the Senate Committee on Health and Long Term Care on January 22<sup>nd</sup>. The substitute bill was passed out of committee on February 1<sup>st</sup> and referred to the Senate Committee on Ways and Means.

*E-cig taxation:* [HB 2165](#), sponsored by Rep Harris, imposes a 60 percent tax on vapor cartridges and "e-liquid.", creates the Essential Public Health Services Account, and authorizes the Governor to enter into vapor products taxation compacts with federally recognized Indian tribes and establishes requirements for such compacts. The bill passed out of House Finance on January 23<sup>rd</sup> and was sent to the House Committee on Appropriations.

Inactive

*Opioid Prescriptions:* [HB 2272/SB 6050](#), requested by the Attorney General and sponsored by Rep. Cody and Sen. Cleveland, concerns restrictions on prescriptions for opiates and provides that practitioners prescribing an opiate to a patient for the first time for outpatient use may only issue a prescription for no more than a seven-day supply for patients twenty-one years and older and a three-day supply for those under twenty-one. HB 2272 received a public hearing in the House Committee on Health Care and Wellness on January 12<sup>th</sup>. SB 6050 received a public hearing in the Senate Committee on Health and Long Term Care on January 15<sup>th</sup>.

*Prescription Monitoring Program:* [HB 2325/SB 6028](#), requested by the Attorney General and sponsored by Rep. Riccelli and Sen. Van De Wege, requires practitioners prescribing an opiate or benzodiazepine to review the patient's controlled substance history in the prescription monitoring program. HB 2325 received a public hearing in the House Committee on Health Care and Wellness on January 12<sup>th</sup>. SB 6028 received a public hearing in the Senate Committee on Health and Long Term Care on January 15<sup>th</sup>.

[HB 2501](#), sponsored by Rep. Caldier, requires that the prescription monitoring program (PMP) be integrated with all federally-certified health record technologies and directs the Department of Health to establish a technical assistance program to help health care providers and facilities attempting to access the PMP. It received a public hearing in the House Committee on Health Care and Wellness on January 19<sup>th</sup>.

*Diversity in Clinical Trials:* [HB 2304/SB 6506](#), sponsored by Rep, Lovick, directs the Washington State Review Board to establish a program to encourage diversity in clinical trials for drugs and medical devices for underrepresented demographic groups and requires state entities that conduct clinical trials of drugs or medical devices to adopt policies for identifying and recruiting members of underrepresented demographic groups to participate in clinical trials. It received a public hearing in the House Committee on Healthcare and Wellness on January 9<sup>th</sup>. SB 6506 received a public hearing in the Senate Committee on Health and Long Term Care on January 30<sup>th</sup>.

## **Education**

*Basic Education Provisions:* There were a suite of bills modifying the education bill from the 2017 session, HB 2242, which received a hearing on Monday January 22<sup>nd</sup> in the Senate. These bills include: [SSB 6362](#) ([HB 2721](#)) sponsored by Sen. Wellman, [SB 6397](#) ([HB 2717](#)) sponsored by Sen.

Hunt, and [SB 6483](#) sponsored by Sen. Conway. SB 6362 was substituted on January 25<sup>th</sup> and referred to Ways and Means. The bill received a public hearing in the Senate Committee on Ways and Means on February 1<sup>st</sup>. An additional 2242 fix bill, [SB 6352](#), sponsored by Sen. Nelson, also received a public hearing in the Senate Committee on Ways and Means on February 1<sup>st</sup>.

The house versions of several 2242 fix bills received hearings on January 31<sup>st</sup>. These included [HB HB 2717](#) sponsored by Rep. Dolan, and [HB 2721](#) sponsored by Rep. Sullivan.

*Breakfast After the Bell:* [HB 1508](#), sponsored by Rep. Stonier, promotes student health and readiness through meal and nutrition programs (aka Breakfast After the Bell) passed off the Senate floor with a strong bipartisan vote of 43-5. This puts the bill one step closer to becoming law. The bill was amended in Senate Ways & Means to remove language that would limit the amount of added sugar to 25% by weight, which is not possible for schools to implement given current labeling requirements. Instead, language was added in requiring OSPI to develop guidance for low sugar foods. The amendment also removed language requiring school gardens to be “organic” after it was determined that this would be very difficult and cumbersome for schools to implement. The House now needs to concur on these changes before the bill heads to the Governor for signature.

[SB 6003](#), sponsored by Sen. Wellman, concerns breakfast after the bell programs in certain public schools and requires high-needs schools to offer breakfast after the bell to each student beginning in the 2019-20 school year and only in years in which funding is specifically provided in a budget. The bill was voted off the Senate floor on January 19<sup>th</sup> with a 40-8 vote count and has been referred to the House Committee on Education.

*CTC Academic Employee Collective Bargaining:* [SB 5993](#), sponsored by Sen. Keiser, authorizes boards of trustees of community and technical colleges to provide additional compensation to academic employees that exceeds the amount or percentage established by the Legislature. The bill received a public hearing in the Senate Committee on Labor and Commerce on January 15<sup>th</sup>. It passed out of committee on January 24<sup>th</sup>. The bill received a public hearing in the Senate Committee on Ways and Means on February 1<sup>st</sup>.

*Early Learning Levy:* [HB 2898/SB 6458](#), sponsored by Sen. Billig and Rep. Kagi, authorizes school districts to levy an additional enrichment levy of up to \$0.25 per \$1,000 of assessed property value to support high quality early learning programs. HB 2898 received a public hearing in the House Committee on Early Learning and Human Services on January 26<sup>th</sup> and was scheduled for executive action on January 31<sup>st</sup>, but no action was taken. SB 6458 received a public hearing in the Senate Committee on Ways and Means on January 30<sup>th</sup>.

*ECEAP Eligibility:* [HB 2659](#), sponsored by Rep. Goodman, modifies the family income limit for Early Childhood Education and Assistance Program (ECEAP) eligibility from 110 percent of the Federal Poverty Level (FPL) to 185 percent of FPL, adds prioritization criteria for ECEAP enrollment, and phases in biennial funding and extends the date for full statewide implementation of ECEAP from the 2022-23 school year to the 2028-29 school year. The bill received a public hearing in the House Committee on Early Learning and Human Services on January 26<sup>th</sup> and was passed out of committee on January 31<sup>st</sup>. It has been referred to the House Committee on Appropriations.

*Emotional Distress:* [SB 6141/HB 2496](#), sponsored by Sen. McCoy and Rep. Kagi, requires the Office of the Superintendent of Public Instruction (OSPI) to develop an online one-hour training module for

school staff on recognition, screening, and response to emotional or behavioral distress in students and directs educational service districts (ESDs) to identify a regional mental health coordinator with certain responsibilities. SB 6141 received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 16<sup>th</sup> and was referred to Ways and Means on January 24<sup>th</sup>. The bill received a public hearing in the Senate Committee on Ways and Means on February 1<sup>st</sup>. HB 2496 received a public hearing in the House Committee on Early Learning and Human Services on January 16<sup>th</sup>.

*Financial Aid and DACA students:* [SSB 5074](#), sponsored by Sen. Frockt, aligns residency requirements for certain state financial aid programs and includes individuals granted Deferred Action for Childhood Arrivals (DACA) status, if they meet other statutory requirements, under the term resident student, as well as establishes the term nonresident student does not pertain to certain visa holders that meet other statutory requirements regarding residency. The bill was voted off the Senate floor on January 24<sup>th</sup> with a 38-11 vote count and was referred to the House Committee on Higher Education on January 26<sup>th</sup>.

[HB 1488](#), sponsored by Rep. Hansen, expands higher education opportunities for certain students by allowing students who qualify for resident tuition under the “1079” category to be eligible for the College Bound Scholarship program. HB 1488 received a public hearing in the House Committee on Higher Education and was substituted in executive session on January 24<sup>th</sup>. It is scheduled for a public hearing in the House Committee on Appropriations on February 3<sup>rd</sup>.

*Hunger-Free Student’s Bill of Rights:* [HB 2610](#), sponsored by Rep. Peterson, requires schools to provide a meal that qualifies for federal reimbursement to students requesting a meal regardless of the students' ability to pay, prohibits schools and districts from publicly identifying or stigmatizing a student who cannot pay for a school meal, and requires local liaisons for homeless students to coordinate with the applicable school nutrition program to ensure that each homeless student has proper access to free school meals. The bill received a public hearing in the House Committee on Education on January 15<sup>th</sup> and was passed out of committee on January 25<sup>th</sup>. It had a public hearing in the House Committee on Appropriations on February 3<sup>rd</sup>.

*Lunch Co-Pays:* [HB 2712](#), sponsored by Rep. Gregerson, eliminates lunch copays for students who qualify for reduced-price lunches under the National School Lunch Program. It received a public hearing in the House Committee on Appropriations on January 24<sup>th</sup>. Executive session was scheduled on January 31<sup>st</sup>, but no action was taken.

*Puget Sound Taxpayer Accountability Account:* [HB 2488/SB 6306](#), sponsored by Rep. Sullivan and Sen. Frockt, allows counties to use funding distributed from the Puget Sound Taxpayer Accountability Account for facilities to improve educational outcomes, in addition to educational services. HB 2488 received a public hearing in the House Committee on Appropriations on January 24<sup>th</sup>.

*Opioid Medications:* [HB 2390/SB 6469](#), sponsored by Rep. Pollet and Sen. Palumbo, allows kindergarten through twelfth grade (K-12) schools to obtain, maintain, and administer opioid overdose medication through a standing order from a health care practitioner for the purpose of assisting a person at risk of experiencing an opioid related overdose. The bill includes provisions related to K-12 school opioid-overdose policies, staff trainings, and liability. It also requires certain public institutions of higher education to develop plans for the maintenance and administration of opioid overdose medication in and around the residence halls. HB 2390 received a public hearing in the House Committee on Education on January 16<sup>th</sup> and the substitute bill passed out of committee on January

25<sup>th</sup>. The bill was referred to Appropriations and is scheduled for a public hearing on February 5<sup>th</sup>. SB 6469 has been referred to the Senate Committee on Health and Long Term Care but has not received any action.

*School Safety:* [SSB 6410](#), sponsored by Sen. Padden, requires first responder agencies to notify all schools in the vicinity, including private schools, if there is a situation for which an evacuation or lockdown appears reasonably necessary, provides that all school buildings occupied by public or private school students must be mapped, but nothing requires them to be mapped unless the entire cost of mapping is provided, and directs educational service districts (ESDs) to establish regional school safety centers as part of a statewide network. The bill received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 29<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and the substitute bill passed out and was referred to the Senate Committee on Ways and Means. It is scheduled for a public hearing on February 5<sup>th</sup>.

*Washington Promise:* [HB 1840/SB 5666](#), sponsored by Rep. Pollet and Sen. Frockt, establishes the Washington Promise Program to provide free community and technical college tuition and fees to eligible students. No action has been taken on either of these bills in 2018.

Inactive

*Childcare Subsidy:* [SB 6100](#), sponsored by Sen. Ranker, allows individuals participating in higher education programs, including public or private four-year colleges or universities, to be eligible for Working Connections Child Care (WCCC) benefits and provides that these individuals do not need to work as a condition of receiving WCCC benefits. It received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 23<sup>rd</sup>.

*Community and Technical College Tuition:* [SB 6543](#), sponsored by Rep. Braun, reduces tuition at community and technical colleges by 10 percent in the 2018-19 academic year and directs the Legislature to appropriate the net revenue loss from the reduction in resident undergraduate operating fees. The bill has not received action yet this session.

*Homeless Students:* [SB 6148](#), sponsored by Sen. Palumbo, directs certain state agencies to convene a workgroup with aligned nongovernmental agencies to create a plan for children and youth experiencing homelessness to achieve educational equity with their general student population peers and tasks the workgroup with addressing certain topics and submitting a report to the Legislature by December 17, 2018. The bill received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 29<sup>th</sup>.

*Landmarked Schools:* [SB 5805](#), sponsored by Sen. Frockt, concerns the application of landmark or historic preservation regulations and provides that school district property in districts with more than 50,000 students is subject to state and local landmark or historic preservation regulations only to the extent explicitly approved by the school district board of directors. The bill requires the school district board of directors to consult with relevant state and local landmark or historic preservation authorities. SB 5805 received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 11<sup>th</sup>.

*Working Connections:* [SB 6464](#), sponsored by Sen. Zeiger, directs the Washington State Institute for Public Policy (WSIPP) to analyze certain topics in the Working Connections Child Care program by

December 1, 2018. The bill received a public hearing in the Senate Committee on Early Learning and K-12 Education on January 30<sup>th</sup>.

## **Public Safety**

*Body Cameras:* [HB 2893/SB 6408](#), sponsored by Sen. Padden and Rep. Hansen, removes expiration dates, making current requirements and Public Records Act (PRA) provisions governing worn cameras permanent and applicable to all law enforcement and corrections agencies deploying body worn cameras, adds a definition of intimate images as it relates to body worn camera recordings, and clarifies records retention requirements for body worn camera recordings. SB 6408 received a public hearing in the Senate Committee on Law and Justice. The Senate Law and Justice committee voted this bill out unanimously on February 1<sup>st</sup> and the bill was passed to the Rules Committee.

*Closing Loopholes:* On January 23<sup>rd</sup>, the Senate Law and Justice Committee held a hearing on three bills that would help keep firearms away from people who are at risk of harming themselves or other people. [SB 6297](#), sponsored by Sen. Dhingra, allows restriction of firearm possession by people who have been found incompetent to stand trial and who have a history of one or more violent acts. A substitute bill was passed out of committee on a bipartisan vote on January 30<sup>th</sup> and referred to the Rules Committee for second reading. [SB 6298](#), sponsored by Sen. Dhingra, adds domestic violence harassment to the list of offenses for which a person is prohibited from possessing a firearm. The bill was passed out of committee on January 30<sup>th</sup> and referred to the Rules Committee for second reading. And [SB 5441](#) allows the temporary restriction of firearm rights for individuals detained for 72 hours under the mental health involuntary treatment act. This bill was passed out of committee on February 1<sup>st</sup> and referred to the Rules Committee for second reading.

*Domestic Violence:* [HB 2457](#), sponsored by Rep. Goodman, specifies timeframes for which domestic violence no-contact orders entered as a condition sentence remain in effect and extends the maximum time that a superior court may suspend a non-felony domestic violence sentence to five years. The bill received a public hearing in the House Committee on Public Safety on January 15<sup>th</sup> and January 25<sup>th</sup>, when it was voted out of committee. It has been referred to the Rules Committee for review.

*DNA Samples:* [HB 2331](#), sponsored by Rep. Orwall, addresses the collection of DNA biological samples and applies the DNA collection and analysis law to persons convicted under a municipal ordinance that is equivalent to a state criminal statute for which DNA is collected upon conviction. The bill received a public hearing in the House Committee on Public Safety on January 9<sup>th</sup> and executive action was taken on February 1<sup>st</sup>. The substitute bill passed and was referred to the Rules Committee for review.

*Driving While License Suspended 3e:* [HB 2481/SSB 6189](#), sponsored by Sen. Fain and Rep. Graves, reclassifies Driving a Motor Vehicle with a Suspended or Revoked Driver's License in the third degree from a misdemeanor criminal offense to a civil traffic infraction. HB 2481 received a public hearing in the House Committee on Public Safety on January 29<sup>th</sup> and executive action was scheduled, but no action was taken, on January 30<sup>th</sup> and February 1<sup>st</sup>. SB 6189 received a public hearing in the Senate Committee on Law and Justice and was voted out of committee February 1<sup>st</sup>. The bill passed is scheduled for a public hearing in the Senate Committee on Transportation on February 5<sup>th</sup>.

*Enhanced Assault Weapon Background Checks, Restoration of Local Authority, Protecting Preschools:* On January 25<sup>th</sup>, the House Judiciary committee held a packed hearing on several gun



safety measures. These included restoring local authority to create gun safety laws ([HB 2666](#)), requiring that people be 21 years old and pass an enhanced background check to own an Assault Weapon ([HB 1387](#)), protecting early learning facilities ([HB 2293](#)) and ensuring a thorough background check and victim notification process is followed before a concealed pistol license is returned ([HB 2519](#)). Executive action was taken on HB 2519 on February 1<sup>st</sup> and was referred to the Rules Committee. The Senate Law and Justice committee voted to advance Enhanced Assault Weapon Background checks (SB 5444) and the bill was referred to the Rules Committee.

*Electronic Monitoring:* [SB 6292](#), sponsored by Sen. Wilson, defines electronic monitoring to include electronic monitoring with victim notification technology (EMVNT) that is capable of notifying a victim or protected party if the monitored individual is nearby, requires the Administrative Office of the Courts to develop a list of vendors that can provide EMVNT and an informational handout for victims on the availability of EMVNT and, to the extent funds are appropriated, provide funding to counties to cover the cost of EMVNT. The bill also gives state and local government immunity from liability for the utilization of EMVNT unless it acted with gross negligence or in bad faith. It received a public hearing in the Senate Committee on Law and Justice on January 23<sup>rd</sup> and was passed out of committee on January 30<sup>th</sup>. The bill has been referred to the Rules Committee for second reading.

*First Informer Broadcasters:* [HB 2415](#), sponsored by Rep. Chapman, requires the Military Department Emergency Management Division to authorize a private entity to establish a program for certifying first informer broadcasters and requires state and local governments to allow certified first informer broadcasters access to areas affected by emergencies in some circumstances. The bill received a public hearing in the House Committee on Public Safety on January 15<sup>th</sup> and passed out of committee on January 25<sup>th</sup>. It has been referred to the Rules Committee.

*Immunity from Prostitution Offenses:* [HB 2361](#), sponsored by Rep. Pellicciotti, provides immunity from prosecution for prostitution if the evidence for the charge was obtained as a result of a person seeking emergency assistance in certain circumstances. The bill received a public hearing in the House Committee on Public Safety on January 16<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and the substitute bill pass out of committee and was referred to the Rules Committee.

*Machine Gun Loophole -- Trigger Modification Devices:* [SB 5992](#), sponsored by Sen. Van de Wege, closes the machine gun loophole by prohibiting bump stocks designed to accelerate a firearm's rate. The bill was voted off the Senate floor on January 25<sup>th</sup> with a 29-20 vote count. The bill is scheduled for a public hearing in the House Committee on the Judiciary on February 9<sup>th</sup>.

*Modifying Rape Offense:* [HB 2465](#), sponsored by Rep. Orwall, modifies the crime of Rape in the third degree by removing the language requiring that lack of consent was clearly expressed by the victim's words or conduct. Instead, a person commits Rape in the third degree when such person engages in sexual intercourse with another person where the victim did not consent to sexual intercourse with the perpetrator or where there is threat of substantial unlawful harm to the property rights of the victim. It received a public hearing in the House Committee on Public Safety on January 16<sup>th</sup> and passed out of committee on January 25<sup>th</sup>. The bill was referred to the Rules Committee.

*No-Contact Violations:* [HB 2466](#), sponsored by Rep. Orwall, includes no-contact orders issued in Promoting Prostitution and Trafficking cases in the list of orders to which the warrantless arrest statute applies. The bill received a public hearing in the House Committee on Public Safety on January 16<sup>th</sup> and passed out of committee on January 25<sup>th</sup>. The bill was referred to the Rules Committee.

*Patronizing a Prostitute:* [HB 2360](#), sponsored by Rep. Pellicciotti, raises the classification for the crime of Patronizing a Prostitute from a misdemeanor to a gross misdemeanor. The bill received a public hearing in the House Committee on Public Safety on January 16<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and the substitute bill passed out of committee.

*Repealing the Death Penalty:* [SB 6052](#), sponsored by Rep. Walsh, eliminates the death penalty and provides that all persons convicted of Aggravated First Degree Murder must be sentenced to life in prison without the possibility of release or parole. The bill received a public hearing in the Senate Committee on Law and Justice Committee on January 22<sup>nd</sup> and passed out of committee on January 25<sup>th</sup>. It has now been passed to the Rules Committee for second reading.

*Reviewing Sexual Predatory Standards:* [SB 6217](#), sponsored by Sen. Dhingra, provides review standards for the court to follow in determining whether to order a full evidentiary hearing on whether to order the unconditional discharge or conditional release (CR) to a less restrictive alternative (LRA) of a person committed as a sexually violent predator (SVP). It received a public hearing in the Senate Committee on Human Services and Corrections on January 24<sup>th</sup> and was passed out of committee on January 30<sup>th</sup>. The bill has been referred to the Rules Committee for second reading.

*Sexual Assault Kits:* [HB 2353](#), sponsored by Rep. Orwall, provides funding for processing of the 6,000+ untested rape kits, for investigative training and increased rights for victims of sexual assault. HB 2353 received a public hearing in the House Committee on Public Safety on January 9<sup>th</sup> and was passed out of committee on January 25<sup>th</sup>. The bill has been referred to the House Committee on Appropriations.

*Sexual Assault, Statute of Limitations:* [HB 1155](#), sponsored by Rep. Griffey, eliminates the statute of limitations for felony sexual offenses, including rape in the first and second degrees, child molestation and sexual exploitation of a minor is ready to be voted on the House floor. The bill has been placed on third reading by the House Rules Committee.

*Sexual Harassment Unified Table:* [HCR 4413](#), sponsored by Rep. Tarleton, creates a unified table on sexual harassment and establishing a sexual harassment work force was passed on a voice vote on January 18 and is headed to the Senate. The task force will be made up of eight legislators (representing the four corners), four lobbyists and one representative each from the Office of the Secretary of the Senate and the Chief Clerk of the House. It was adopted in the House on January 18<sup>th</sup> and has been placed on the Senate's second reading calendar.

*Sexual Harassment Public Records:* [SHB 2778](#), sponsored by Rep. Jinkins, expands the public records exemptions to include personal information of an agency employee who makes a sexual harassment claim and requests that their information not be disclosed and subjects a person to civil liability who requests and obtains the personal information of an agency employee who makes a sexual harassment claim if the requestor uses the information to harass, stalk, threaten, or intimidate the employee. The bill received a public hearing in the House Committee on State Government, Elections and Information Technology on January 30<sup>th</sup> and received executive action on January 31<sup>st</sup>. The substitute bill passed out of committee and has been referred to the Rules Committee.

*Suicide Prevention/Voluntary Waiver:* [SB 5553](#), sponsored by Sen. Pedersen, is a suicide prevention policy that allows people to sign a voluntary waiver of firearms rights. Among other things, it requires entry of the voluntary waiver into the Washington State Patrol electronic database and prohibits

transfer of a firearm to a person with a voluntary waiver in effect. The bill passed unanimously out of the Senate on January 24<sup>th</sup>. It is scheduled for a public hearing in the House Committee on the Judiciary on February 9<sup>th</sup>.

*Vacating Criminal Convictions:* [HB 2890](#), sponsored by Rep. Hansen, modifies the process for obtaining a certificate of discharge and expands eligibility criteria for vacating criminal convictions. It received a public hearing in the House Committee on Public Safety on January 23<sup>rd</sup> and executive action was taken on February 1<sup>st</sup>. The substitute bill passed and was referred to the Rules Committee.

*Wireless Device Tax/Internet Crimes Against Children:* [HB 2389](#), sponsored by Rep. Sawyer, levies a 40 cent tax on each retail sale in the state of a wireless device used to access the internet and dedicates the revenue of the new tax to the Washington Internet Crimes Against Children Account. The bill received a public hearing in the House Committee on Finance on January 12<sup>th</sup> and the substitute bill was passed out of committee on January 30<sup>th</sup>. The bill has been referred to the House Committee on Appropriations.

## **General Government**

*B&O Tax/Sale of Personal Information:* [HB 1904](#), sponsored by Rep. Smith, imposes a business and occupation tax on the sale of personal information in Washington. The bill received a public hearing in the House Committee on Technology and Economic Development on January 16<sup>th</sup> and was passed out of committee on January 24<sup>th</sup>. The bill has been referred to Appropriations.

*Distributed Energy Resource Planning:* [HB 1233](#), sponsored by Rep. Morris, authorizes an electric utility to develop an annually updated, 10-year Distributed Energy Resources Plan. It received a public hearing in the House Committee on Technology and Economic Development on January 23<sup>rd</sup> and the substitute bill was passed out of committee on January 25<sup>th</sup>. It has been referred to the Rules Committee for review.

*Electrical Billing:* [SB 5624](#), sponsored by Sen. Hasegawa, concerns transparency in retail electrical customer billing and requires each electric utility to provide either written or electronic notice of public hearings where changes in electricity rates will be considered or approved and requires that an electric utility must disclose the local tax rate imposed on the electric utility by a city or town on each billing statement. SB 5624 was voted out of the Senate Committee on Energy, Environment and Technology on January 18<sup>th</sup> and has been placed on the second reading consent calendar.

*Internet Privacy:* [SB 5919](#), sponsored by Sen. Ranker, concerns consumer protection of internet privacy and requires broadband Internet providers to obtain opt-in consent to sell or transfer certain customer information. It also, requires broadband Internet providers to obtain opt-in consent to send or display an advertisement to a customer based on certain customer information. SB 5919 received a public hearing in the Senate Committee on Energy, Environment and Technology on January 11<sup>th</sup> and was passed out of committee on February 1<sup>st</sup>. It has been passed to the Rules Committee for second reading.

[HB 2200](#), sponsored by Rep. Hansen, concerns consumer protection of internet privacy and requires Internet providers to obtain opt-in consent to sell or transfer certain customer information, it also requires Internet providers to obtain opt-in consent to send or display an advertisement to a customer based on certain customer information. The bill received a public hearing on January 18<sup>th</sup> in the House

Committee on Technology and Economic Development and is passed out of committee on January 30<sup>th</sup>. It has been scheduled for a public hearing in Appropriations on February 3<sup>rd</sup>.

*Net Neutrality:* [HB 2282](#), sponsored by Rep. Hansen, prohibits Internet providers from blocking content, applications, services, or non-harmful devices; impairing or degrading traffic on the basis of content, application or service; or favoring some traffic over others in exchange for benefit. It also requires Internet providers to make certain disclosures related to service. The bill received a public hearing in the House Committee on Technology and Economic Development on January 18<sup>th</sup> and passed out of committee on January 25<sup>th</sup>. It received a public hearing in Appropriations on February 3<sup>rd</sup>.

[HB 2284](#), sponsored by Rep. Smith, protecting consumers by prohibiting blocking, throttling, or paid prioritization in the provision of internet service in Washington State. The bill received a public hearing in the House Committee on Technology and Economic Development on January 18<sup>th</sup> and passed out of committee on January 25<sup>th</sup>. It has been referred to Appropriations.

*Private Employer Park and Ride:* [HB 2862](#), sponsored by Rep. Harmsworth, allows private employer transportation service vehicles to use certain park and ride lots regardless of the capacity of the lot. The bill received a public hearing in the House Committee on Transportation on January 29<sup>th</sup>.

*Property Tax Task Force:* [SB 6382](#), sponsored by Sen. Carlyle, creates a task force on state and local property tax reform. It received a public hearing in the Senate Committee on Ways and Means on January 25<sup>th</sup>.

*Small Cell Deployment:* [HB 2592](#), sponsored by Rep. Morris, creates a designation process for local governments that demonstrate investment readiness for small cell infrastructure. The bill received a public hearing in the House Committee on Technology and Economic Development on January 18<sup>th</sup> and the substitute bill passed out of committee February 1<sup>st</sup>. It has been referred to Rules for review.

[SB 5935](#), sponsored by Sen. Sheldon, requires cities and towns to enact an ordinance for issuing master permits for siting and installing small cell facilities, creates the Governor's Office on Broadband Access, establishes a Broadband Taskforce to review existing initiatives, policies, and public/private investments, creates a broadband deployment partnership initiative for underserved or unserved areas, authorizes rural port districts to acquire and operate telecommunications facilities for their own internal telecommunications needs within and outside of its district, and to provide wholesale telecommunications services within its district limits and extends the state Universal Service Fund until 2021. The bill received a public hearing in the Senate Committee on Energy, Environment and Technology on January 25<sup>th</sup> and passed out of committee on February 1<sup>st</sup>. The bill has been referred to The Senate Committee on Ways and Means and is scheduled for a public hearing on February 5<sup>th</sup>.

Inactive

*Consumer Rights to Internet Transparency:* [SB 6446](#), sponsored by Sen. Carlyle, requires providers of broadband Internet access services to publicly disclose information regarding the network management practices, performance, and commercial terms of its broadband internet services, makes a violation of the disclosure requirements, a violation of the Consumer Protection Act (CPA), and prohibits state agencies from entering into new contracts with Internet service providers who do not commit to providing equal connection to all users to lawful Internet content, applications, and services. The bill

received a public hearing in the Senate Committee on Energy, Environment and Technology on January 18<sup>th</sup>.

*Low-income Veterinary Services:* [SB 6196](#), sponsored by Sen. Cleveland, allows qualified animal control agencies and non-profit humane societies to provide veterinary services to animals owned by low-income households. The bill received a public hearing in the Senate Committee on Health and Long Term Care on February 1<sup>st</sup>.

*Net Neutrality:* [SB 6423](#), sponsored by Sen. Ranker, prohibits Internet service providers from blocking, throttling, or engaging in paid prioritization of lawful Internet content, requires the Utility Transportation Commission (UTC) to establish rules to enforce the prohibitions, ensure maximization of Internet neutrality and amend standards for compliance with consumer protection and Internet neutrality provisions, and expires the act when Congress has expressly established net neutrality consumer protections that are substantially equivalent. It received a public hearing in the Senate Committee on Energy, Environment and Technology on January 30<sup>th</sup>.

*Public Facilities:* [HB 2093/SB 5725](#), sponsored by Rep. Santos and Sen. Hasegawa, concerns the mitigation of public facilities in certain cities. The bill requires a city with a population greater than 550,000 that permits, constructs, or operates a public facility in a neighborhood with a high poverty level or high rate of ethnic diversity to assume the responsibility for negative impacts that the public facility has had, or may have, on the surrounding neighborhood. The bill requires a qualifying city to develop a mitigation plan and consider the potential or actual disparate racial, social, and economic impacts of the public facility on nearby residents and authorizes a qualifying city to negotiate with other local jurisdictions who have a direct interest in having created the negative impacts, but the residents must be held harmless. HB 2093 received a public hearing in the House Committee on Local Government on January 9<sup>th</sup>.

## **Environment**

*Alternative Fuel Vehicle Tax Exemption:* [HB 2340](#), sponsored by Rep. Condotta, extends the retail sales and use tax exemption for clean alternative fuel vehicles by modifying the timing for early termination of it to occur after 10,000 qualifying vehicles are titled in the state (rather than after 7,500 qualifying vehicles are titled in the state). The bill received a public hearing in the House Committee on Transportation on January 29<sup>th</sup>.

[HB 2549](#), sponsored by Rep. Muri, expands the retail sales and use tax exemption to apply to vehicles that use at least one method of propulsion that is capable of being reenergized by an external source of electricity and that are capable of traveling at least 20 miles (rather than the current 30 miles) using only battery power and extends the retail sales and use tax exemption for clean alternative fuel vehicles by modifying the timing for early termination of it to occur after 12,500 qualifying vehicles are titled in the state (rather than when 7,500 qualifying vehicles are titled in the state). The bill received a public hearing in the House Committee on Transportation on January 29<sup>th</sup>.

[HB 2653](#), sponsored by Rep. Fey, extends the alternative fuel vehicle retail sales and use tax exemption termination date to June 30, 2021 and eliminates the possibility of early termination of the exemption based on the number of qualifying vehicles titled in the state. The bill received a public hearing in the House Committee on Transportation on January 29<sup>th</sup>. Executive action was taken on January 31<sup>st</sup> and the bill was referred to the Finance Committee.

*Carbon Pricing:* [SB 6203](#), requested by Governor Inslee and sponsored by Sen. Carlyle, was voted out of the Senate Committee on Energy, Environment & Telecommunications on February 2<sup>nd</sup>. The substitute bill would impose a \$10 tax per metric ton which would increase by \$2 per ton until a cap of \$30 per ton is reached. The bill now heads to the Senate Committee on Ways & Means.

*Clean Energy Investments:* [HB 2283](#), sponsored by Rep. DeBolt, suspends the 15 percent annual renewable resource target under the Energy Independence Act beginning January 1, 2028 and requires that electric utilities use electricity generated by clean energy resources to meet any new energy or capacity need beginning January 1, 2028. It also establishes tax preferences for certain renewable energy and carbon reduction investments. The bill received a public hearing in the House Committee on Technology and Economic Development on January 16<sup>th</sup> and the substitute bill was passed out of committee on February 1<sup>st</sup>. It is scheduled for a public hearing and executive session in the House Committee on Finance on February 5<sup>th</sup>.

*Energy Efficiency:* [HB 2931](#), sponsored by Rep. Doglio, establishes a lower efficiency, intermediate efficiency, and high efficiency option for the State Energy Code for residential structures beginning with the 2018 code cycle. The bill received a public hearing in the House Committee on Technology and Economic Development on January 30<sup>th</sup>. The motion to report the bill out of the House Committee on Technology and Economic Development on January 30<sup>th</sup> failed. Executive action was again taken on February 1<sup>st</sup> and a substitute bill passed out of committee.

*Energy Independence Act:* [HB 2402](#), sponsored by Rep. Tarleton, extends the requirement to pursue all available conservation that is cost-effective, reliable, and feasible under the Energy Independence Act (EIA) to small utilities and natural gas utilities. It also adds additional targets under the EIA. The bill received a public hearing in the House Committee on Technology and Economic Development on January 23<sup>rd</sup> and was passed out of committee on February 1<sup>st</sup>.

*Fuel Content Standards:* [SHB 2757/SB 6276](#), sponsored by Sen. Carlyle and Rep. Doglio, amends the state Renewable Fuel Standard (RFS) to require that all diesel fuel sold or offered for sale in Washington for use in motor vehicles upon highways of the state must contain at least 5 percent biodiesel by volume beginning January 1, 2019. HB 2757 received a public hearing and executive session scheduled, but no action was taken in the House Committee on Technology and Economic Development on January 30<sup>th</sup>. The bill was substituted on January 31<sup>st</sup> and referred to the Rules Committee on February 1<sup>st</sup>.

*Net Metering:* [HB 2510](#), sponsored by Rep. Morris, increases the maximum capacity of systems eligible for net metering to 1,000 kilowatts, requires an electric utility to offer to make net metering available to eligible customer-generators until the cumulative generating capacity of net metering systems equals 2.5 percent of the utility's peak demand during 1996, and requires an electric utility that reaches its cumulative net metering generating capacity threshold to first engage in a distributed energy resources planning process that accomplishes certain goals before offering an alternative to net metering.. The bill received a public hearing in the House Committee on Technology and Economic Development on January 16<sup>th</sup> and was the first substitute was passed out of committee on January 25<sup>th</sup>. It has been referred to the Rules Committee.

[SB 6081](#), sponsored by Sen. Palumbo, increases the 0.5 percent minimum threshold to 6 percent for the cumulative generating capacity that a utility must make available for net metering systems, requires, as of March 31, any remaining unused kilowatt-hour (kWh) credit generated for the calendar

year to be used to assist low-income residential utility customers, and requires electric or gas utilities to include on customer bills the total amount of kWh of electricity consumed for the most recent 12-month period. The bill received a public hearing in the Senate Committee on Energy, Environment and Technology on January 17<sup>th</sup>. The substitute bill passed out of the policy committee on January 23<sup>rd</sup> and out of Ways and Means on January 30<sup>th</sup>. The bill has been passed to the Rules Committee for second reading.

*Oil Transportation Safety:* [SB 6269](#), sponsored by Sen. Ranker, applies the barrel tax to crude oil received by pipeline, requires the Department of Ecology (Ecology) to review, assess, and provide a report on vessel traffic safety in northern Puget Sound, requires Ecology to establish the Salish Sea Shared Waters forum, requires Ecology to update contingency plan rules to address situations where oils may sink or submerge in water, and authorizes Ecology to require at least one joint large-scale, multiple plan equipment deployment drill of onshore and offshore facilities and covered vessels, every 3 years. It received a public hearing in the Senate Committee on Energy, Environment and Technology on January 25<sup>th</sup>. The substitute bill was passed out of committee on January 31<sup>st</sup> and referred to Ways and Means.

*On-Bill Repayment:* [HB 2410](#), sponsored by Rep. Doglio, requires each electric utility, except for a small utility or a retail electric cooperative, to offer an on-bill repayment program option to its retail electric customers beginning January 1, 2020. . The bill received a public hearing in the House Committee on Technology and Economic Development on January 17<sup>th</sup>. The substitute bill passed out of committee on January 31<sup>st</sup> and has been referred to Rules.

*Optional Alternative Energy Purchases:* [HB 2413/SB 6477](#), sponsored by Rep. Doglio and Sen. Rolfes, requires utilities to provide the option for residential customers to purchase qualified alternative energy resources. HB 2413 received a public hearing in the House Committee on Technology and Economic Development on January 17<sup>th</sup>. The House substitute, which requires each electric utility to provide the voluntary option to purchase qualified alternative energy resources to each of its new retail electric customers at the time service is established and to provide the option to its existing customers through its website and through quarterly mailings and requires the Department of Commerce and the Utilities and Transportation Commission to jointly report findings and recommendations to the energy committees of the Legislature on best practices and policies for electric utilities to develop green tariffs or similar qualified alternative energy resource options for their retail electric customers, was passed out of committee on January 30<sup>th</sup>. HB 2413 has been referred to the Rules Committee. SB 6477 received a public hearing in the Senate Committee on Energy, Environment and Technology on January 23<sup>rd</sup>.

*Pollution Liability Insurance:* [SHB 2872](#), sponsored by Rep. Peterson, establishes an aggregate limit of \$11 million per calendar year for pollution liability direct insurance provided by the Pollution Liability Insurance Agency. The bill received a public hearing in the House Committee on Environment on January 29<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and the substitute bill passed out of committee.

*Reclaimed Water:* [HB 2743/SB 6390](#), sponsored by Rep. Springer and Sen. Wellman, requires a reclaimed water permit applicant or permittee to enter into certain written agreements with a Group A public water system before the applicant or permittee may use, store, or deliver reclaimed water within the service area of the Group A public water system, requires the written agreements between the reclaimed water permit applicant or permittee and the Group A public water system to address, among

other subjects, protection of groundwater quality and other water resource, an identification of the areas in which reclaimed water will be provided, and rates and charges for reclaimed water and establishes a dispute resolution process in which a Group A public water system and a reclaimed water permit applicant or permittee may petition the Secretary of the Department of Health for a decision in the event the parties are not able to reach an agreement. HB 2743 received a public hearing in the House Committee on Agriculture and Natural Resources on January 24<sup>th</sup>. Executive action was taken on February 1<sup>st</sup> and a substitute bill passed out of committee. SB 6390 received a public hearing in the Senate Committee on Agriculture, Water, Natural Resources and Parks on January 29<sup>th</sup>.

*Renewable Energy Incentives:* [HB 2281](#), sponsored by Rep. Morris, specifies that no Renewable Energy Cost Recovery Incentive Payment Program customer who recertifies their renewable energy system with the Washington State University Extension Energy Program (WSU Energy Program) may continue to receive incentive payments if the cumulative dollar amount of incentive payments made to the customer exceeds 100 percent of the total price of the renewable energy system, requires the WSU Energy Program to collect applicable system price data from each person or community solar project administrator applying for recertification under the Renewable Energy Production Incentive Program, Establishes that only applicants whose systems were installed and operational after July 1, 2010, must provide system operation data such as global positioning system coordinates, tilt, estimated shading, and azimuth when applying to the WSU Energy Program for recertification, and authorizes the WSU Energy Program to waive the requirement to provide applicable system data when extraordinary circumstances exist that result in an unreasonable burden to the applicant. HB 2281 received a public hearing in the House Committee on Technology and Economic Development on January 11<sup>th</sup>. The bill was substituted and moved out of committee on January 24<sup>th</sup>. It has now been referred to Appropriations.

*Solar Gardens:* [HB 2280/SB 6130](#), introduced by Rep. Morris and Sen. McCoy, establishes requirements for community solar garden programs and provides utilities and organizations to develop solar gardens that they can sell units in increments of 1kW to subscribers. HB 2280 received a public hearing in the House Committee on Technology and Economic Development on January 11<sup>th</sup>. The bill was substituted and passed out of committee on January 30<sup>th</sup> and referred to Rules. The House substitute requires an electric utility to submit a community solar garden plan to the Utilities and Transportation Commission or to its appropriate governing authority in order to operate a community solar garden program, requires an electric utility to first engage in a distributed energy resources planning process before developing a community solar garden plan, and establishes requirements for community solar gardens. SB 6130 received a public hearing in the Senate Committee on Energy, Environment and Technology on January 17<sup>th</sup>.

*Toxic Chemicals:* [SB 6413](#), sponsored by Sen Van De Wege, prohibits the sale, manufacture, and distribution of firefighting foam that has perfluoroalkyl and polyfluoroalkyl chemicals (PFAS) intentionally added, requires sellers of firefighting personal protective equipment (PPE) containing PFAS, to notify purchasers of the equipment, and makes a violation of the act subject to a civil penalty not to exceed \$5000 for each first offense and up to \$10,000 civil penalty for subsequent violations. It received a public hearing in the Senate Committee on Energy, Environment and Technology on January 25<sup>th</sup>. The substitute bill was passed out of committee on January 31<sup>st</sup> and referred to Ways and Means. It is scheduled for a public hearing in the Senate Committee on Wats and Means on February 5<sup>th</sup>.

*Transportation Electrification:* [SB 6187](#), sponsored by Sen. Palumbo, authorizes the governing bodies of a municipal utility or a public utility district commission to adopt a transportation electrification



plan that, at a minimum, establishes a finding that utility outreach and investment in the electrification of transportation infrastructure is cost-effective to ratepayers. The bill received a public hearing in the Senate Committee on Energy, Environment and Technology on January 17<sup>th</sup> and was passed out of committee on January 23<sup>rd</sup>. It has been referred to the Rules Committee for second reading.

[HB 2897](#), sponsored by Rep. Morris, requires the governing authority of a municipal electric utility or the commission of a public utility district to engage in a distributed energy resources planning process that accomplishes certain goals before developing a transportation electrification plan and authorizes the governing authority of a municipal electric utility or the commission of a public utility district to offer programs in the electrification of transportation for its customers if it makes a cost-effectiveness determination in accordance with a transportation electrification plan. It received a public hearing in the House Committee on Technology and Economic Development on January 23<sup>rd</sup> and executive action was taken on February 1<sup>st</sup>.

[SSB 6080](#), sponsored by Sen. Palumbo, requires the Department of Commerce (Commerce) to report to the Legislature and the Governor on the progress of and recommendations on meeting the fuel usage goal, creates a Clean Energy Account, shifts funding of the electric vehicle (EV) sales and use tax exemption from the Multimodal Transportation Account to the Clean Energy Account under certain conditions, requires Commerce to create the Charge Ahead Washington Program (program), makes the EV sales and use tax exemption permanent, amends EV sales and use tax exemptions, permits the adoption of California vehicle emissions standards for medium-duty trucks and California's zero-emission vehicle (ZEV) requirements. The bill received a public hearing in the Senate Committee on Energy, Environment and Technology on January 31<sup>st</sup>. Executive action was taken on February 1<sup>st</sup> and a substitute bill was passed out of committee and referred to Rules.

*Transportation Fuel Emissions:* [HB 2338](#), sponsored by Rep. Fitzgibbon, aims to reduce the greenhouse gas emissions associated with transportation fuels. The bill directs the Department of Ecology (ECY) to adopt a rule establishing the Clean Fuels Program to limit the greenhouse gas emissions per unit of transportation fuel energy to 10 percent below 2017 levels by 2028, excludes exported fuel, fuel used by vessels, railroad locomotives, and aircraft, and certain other categories of fuel from Clean Fuels Program requirements, requires the Clean Fuel Program to include processes for the tracking of compliance obligations and bankable, tradeable credits, requires annual reporting by the ECY on the Clean Fuels Program, as well as an analysis of the program's first five years by the Joint Legislative Audit and Review Committee, and retains the current distribution of revenue under the 2015 Transportation Revenue Package, eliminating changes that would have been triggered as a result of legislative enactment of a Clean Fuels Program. HB 2338 received a public hearing in the House Committee on Environment on January 9<sup>th</sup>. The bill was substituted and voted out of Committee on January 23<sup>rd</sup>. The bill is scheduled for public hearing in the House Committee on Transportation on February 5<sup>th</sup>.

*Underground Storage:* [HB 2453/SB 6159](#), requested by the Department of Ecology and sponsored by Rep. Peterson and Sen. Takko, extends the expiration date for the state Underground Storage Tank program from 2019 to 2029. HB 2453 was voted out of the House Committee on Environment on January 18<sup>th</sup> and received a public hearing in the House Committee on Appropriations on February 1<sup>st</sup>. SB 6159 was voted out of the Senate Committee on Energy, Environment and Technology on January 18<sup>th</sup> and has been passed to the Rules Committee for second reading.

*Vehicle Fuel Standards:* [HB 2328](#), sponsored by Rep. Morris, adopts California vehicle standards for zero-emission vehicles and for medium duty trucks. The bill received a public hearing in the House Committee on Environment on January 18<sup>th</sup> and the bill was passed out of committee on February 1<sup>st</sup>.

*Wasted Food:* [HB 2411](#), sponsored by Rep. Doglio, establishes a goal of reducing wasted food in the state by 50 percent by 2030 and directs the Department of Ecology to work with the departments of Health and Agriculture to develop a food waste reduction plan by 2020 to achieve the 2030 wasted food reduction goal. The bill received a public hearing in the House Committee on Environment on January 18<sup>th</sup>. The bill was substituted and passed out of committee on February 1<sup>st</sup>; it was then referred to the House Committee on Appropriations.

Inactive

*Paris Climate Agreement:* [HB 2294](#), sponsored by Rep. Slatter, aligns the Washington's greenhouse gas emissions limits with those established by the United States' commitment under the 2015 Paris climate agreement by modifying state greenhouse gas emissions reduction targets to 26 percent below 2005 levels by 2025. The bill also directs the departments of Commerce and Ecology to document and report state and local efforts at reducing carbon emissions. HB 2294 received a public hearing in the House Committee on Environment on January 9<sup>th</sup>.

## **Transportation**

*Alaskan Way Viaduct:* [HB 2741/SB 6378](#), sponsored by Rep. Clibborn and Sen. Hobbs, establishes that tolls must be used to re-pay the transportation partnership account for any amounts transferred from the transportation partnership account to the highway bond retirement fund. HB 2741 received a public hearing in the House Committee on Transportation on January 31<sup>st</sup> and is scheduled for executive session on February 6<sup>th</sup>. SB 6378 is scheduled for a public hearing in the Senate Committee on Transportation on February 5<sup>th</sup>.

*Electric Bicycles:* [HB 2782/SB 6434](#), sponsored by Rep. Kilduff and Sen. Rolfes, concerns electric-assisted bicycles. SB 6434 received a public hearing in the Senate Committee on Transportation on January 31<sup>st</sup> and is scheduled for executive session on February 6<sup>th</sup>. HB 2782 received a public hearing in the House Transportation Committee on January 31<sup>st</sup> and is scheduled for executive session on February 6<sup>th</sup>.

*Regional Transit Authority Board Members:* [SB 6301](#), sponsored by Sen. O'Ban, modifies the election and authority of regional transit authority board members. SB 6301 received a public hearing in the Senate Committee on Transportation on January 24<sup>th</sup>.

*RTA Adjustment:* [SB 5955](#), sponsored by Sen. Kuderer, requires a regional transit authority (RTA) to implement a market value adjustment program, which calculates a credit on motor vehicle excise taxes and requires the RTA to implement the program in a manner that allows the delivery of the system and financing plan approved by the RTA's voters to the extent practicable. It received a public hearing in the Senate Committee on Transportation on January 24<sup>th</sup>.

[SB 6303](#), sponsored by Sen. O'Ban, requires a Regional Transit Authority (RTA) to establish a motor vehicle excise tax (MVET) market value adjustment program (MVAP), requires that the amount of a credit under the MVAP is the difference between the current MVET and an assumed MVET of 0.5 percent based on base model Kelley Blue Book values or National Automobile Dealers Association

(NADA) values, whichever is lower and requires Department of Licensing (DOL) to only contract with an RTA for collection of a MVET if it has implemented a MVAP, and any contract with a RTA must provide DOL with full cost recovery. It received a public hearing in the Senate Committee on Transportation on January 24<sup>th</sup>.

*RTA MVET Payment Plans:* [HB 2357](#), sponsored by Rep. Reeves, allows for semiannual or quarterly payment plans for regional transit authority motor vehicle excise taxes. It received a public hearing in the House Committee on Transportation on January 11<sup>th</sup> and is scheduled for executive session on February 6<sup>th</sup>.

*Transit-Only Lane Enforcement Cameras:* [HB 2403](#), sponsored by Rep. Fitzgibbon, allows local governments to enact an ordinance allowing for the use of transit-only lane enforcement cameras. HB 2403 received a hearing in the House Committee on Transportation on January 15<sup>th</sup> and was substituted and passed out of committee on January 17<sup>th</sup>. The bill has been referred to the Rules Committee.

*Transportation Network Companies:* [SB 6043/HB 2716](#), sponsored by Sen. Hobbs and Rep. Tarleton, provides statewide uniform regulation for transportation network companies. SB 6043 received a public hearing in the Senate Committee on Transportation on January 22<sup>nd</sup> and is scheduled for executive session on February 5<sup>th</sup>. HB 2716 received a public hearing in the House Committee on Transportation on February 1<sup>st</sup> and is scheduled for executive session on February 6<sup>th</sup>.

[SB 6500/HB 2945](#), sponsored by Sen. Saldaña and Rep. Fey, also concerns transportation network companies. SB 6500 received a public hearing in the Senate Committee on Transportation on January 22<sup>nd</sup>. HB 2945 received a public hearing in the House Committee on Transportation on February 1<sup>st</sup> and is scheduled for executive session on February 6<sup>th</sup>.

Exceptions to these deadlines include bills necessary to implement the budget. The House of Origin Cutoff is on February 14<sup>th</sup>.
