6 7 8 9	AN ORDINANCE relating to land use and zoning, amending Sections 23.47A.005 and 23.47A.009 of the Seattle Municipal Code to adopt development standards for certain properties in the Ballard Hub Urban Village; amending the Official Land Use Map at pages 53, 54, and 55 to rezone land in the Ballard Hub Urban Village;
10 11 12 13	body WHEREAS, the Ballard Hub Urban Village population increased by 24 percent between 2000 and 2010; and
14 15 16 17	WHEREAS, in 2013, the Seattle Office of Economic Development awarded an "Only in Seattle" grant to the Ballard Chamber of Commerce to initiate the Ballard Partnership for Smart Growth, a collaboration between business, resident, and community organizations; and
18 19 20 21	WHEREAS, Sound Transit's Long-Range Plan includes high capacity transit service between downtown Seattle and Ballard, and has indicate that it will fund the service as part of "Sound Transit 3" funding package that is proposed for a ballot measure in November, 2016; and
22 23 24	WHEREAS, the Move Seattle Levy funded enhanced RapidRide corridors between Ballard and downtown Seattle and Ballard and the University District neighborhood; and
25 26 27 28	WHEREAS, since 2014, the Seattle Office of Planning and Community Development and the Seattle Department of Transportation have worked with the Ballard Partnership for Smart Growth, the community, and City departments to develop a coordinated urban design and transportation framework plan to support growth and livability in Ballard; and
29 30 31 32	WHEREAS, the framework plan recommends new development standards; transportation improvements, and infrastructure improvements to improve the Ballard neighborhood; and
33 34	WHEREAS, the Council finds that the proposed rezones meet the Land Use Code rezone criteria contained in SMC Chapter 23.34, as further described in the Office of Planning and Community
35 36	Development Director's Report for this legislation; and
37 38 39	WHEREAS, the Council finds that adoption of this ordinance will protect and promote the health, safety and welfare of the general public;
40 41	NOW, THEREFORE,

1	BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:
2	Section 1. The Official Land Use Map, Chapter 23.32 of the Seattle Municipal Code, is amended to
3	rezone properties identified on pages 54 and 55 of the Official Land Use Map, as shown on Exhibit A
4	attached to this Ordinance.
5	Section 2. Section 23.47A.005 of the Seattle Municipal Code, last amended by Ordinance
6	124770, is amended as follows:
7	23.47A.005 Street-level uses
8	A. The requirements of this Section 23.47A.005 apply in addition to the other applicable
9	requirements of this Title 23.
10	B. Mini-warehouses, warehouses, or utility uses may not abut a street-level street-facing
11	facade in a structure that contains more than one residential dwelling unit.
12	C. Residential uses at street level
13	1. In all NC and C zones, residential uses may occupy, in the aggregate, no more
14	than 20 percent of the street-level street-facing facade in the following circumstances or
15	locations:
16	a. In a pedestrian-designated zone, facing a designated principal pedestrian
17	street; or
18	b. In all NC and C1 zones within the Bitter Lake Village Hub Urban
19	Village, except lots abutting Linden Avenue North, north of North 135th Street; or
20	c. In all NC and C1 zones within the Lake City Hub Urban Village, except
21	as provided in subsection 23.47A.005.C.2; or
22	d. Within a zone that has a height limit of 85 feet or higher, except as
23	provided in subsection 23.47A.005.C.2; or

1	e. Within an NC1 zone, except as provided in subsection 23.47A.005.C.2;
2	or
3	f. In all NC and C1 zones within the Northgate Overlay District, except as
4	provided in Section 23.71.044; or
5	g. In all NC and C1 zones within the areas shown on ((Maps 1 through 5))
6	Maps A through D for 23.47A.005.C at the end of this Chapter 23.47A when facing an arterial
7	street.
8	2. Subsection 23.47A.005.C.1 notwithstanding, there is no restriction on the
9	location of residential uses in the following circumstances:
10	a. Within a very low-income housing project existing as of May 1, 2006,
11	or within a very low-income housing project replacing a very low-income housing project
12	existing as of May 1, 2006, on the same site; or
13	b. The residential use is an assisted living facility or nursing home and
14	private living units are not located at street level; or
15	c. Within the Pike/Pine Conservation Overlay District, for street-facing
16	facades that do not face a designated principal pedestrian street, as shown on Map A for
17	23.73.008; or
18	d. In a structure existing on January 1, 2012, that is within an NC1 zone
19	but not located in an area defined in Maps 1 through 60 for 23.47A.005.C, at the end of this
20	Chapter 23.47A, a live-work space may be converted to an accessory dwelling unit if the
21	residential use is established, if the area proposed to be converted meets the minimum housing
22	standards of Chapter 22.206, and if the area proposed to be converted meets the owner
23	occupancy requirement of subsection 23.44.041.C; or

1	e. Within a structure that:
2	1) is developed and owned by the Seattle Housing Authority; and
3	2) is located on a lot zoned NC1 or NC3 that was owned by the
4	Seattle Housing Authority as of January 1, 2009.
5	3. Additions to, or on-site accessory structures for, existing single-family
6	structures are permitted outright.
7	4. Where residential uses at street level are limited to 20 percent of the street-level
8	street-facing facade, such limits do not apply to residential structures separated from the street lot
9	line by an existing structure meeting the standards of this Section 23.47A.005 and Section
10	23.47A.008, or by an existing structure legally nonconforming to those standards.
11	D. In pedestrian-designated zones the locations of uses are regulated as follows:
12	1. Along designated principal pedestrian streets, one or more of the following uses
13	are required along 80 percent of the street-level street-facing facade in accordance with the
14	standards provided in subsection 23.47A.008.C.
15	a. Arts facilities;
16	b. Community gardens;
17	c. Eating and drinking establishments;
18	d. Entertainment uses, except for adult cabarets, adult motion picture
19	theaters and adult panorams;
20	e. Food processing and craft work;
21	f. Institutions, except hospitals or major institutions;
22	g. Lodging uses;
23	h. Medical services;

1	i. Offices, provided that no more than 30 feet of the street-level street-
2	facing facade of a structure may contain an office use;
3	j. Parks and open spaces;
4	k. Rail transit facilities;
5	1. Retail sales and services, automotive, in the Pike/Pine Conservation
6	Overlay District if located within an existing structure or within a structure that retains a
7	character structure as provided in Section 23.73.015;
8	m. Sales and services, general; and
9	n. Sales and services, heavy, except for heavy commercial sales, and
10	provided that no more than 30 feet of the street-level street-facing facade of a structure may
11	contain a non-household sales and service use.
12	The establishment of any such use is subject to the applicable use provisions of this Title
13	23.
14	2. The following streets are principal pedestrian streets when located within a
15	pedestrian-designated zone:
16	10th Avenue;
17	11th Avenue;
18	12th Avenue;
19	13th Avenue, between East Madison Street and East Pine Street;
20	14th Avenue South, except within the North Beacon Hill Residential Urban Village;
21	15th Avenue East;
22	15th Avenue Northeast, north of Lake City Way Northeast;
23	15th Avenue Northwest;







((Map 2 for 23.47A.005.C: 15th Ave West))





((Map 3 for 23.47A.005.C: Uptown Urban Center West))



((Map 4 for 23.47A.005.C: Uptown Urban Center East))



Map A for 23.47A.005.C: 15th Ave West






Map B for 23.47A.005.C: Uptown Urban Center West

1	Section 2. Section 23.47A.009 of the Seattle Municipal Code, last amended by Ordinance 123478, is
2	amended as follows:
3	23.47A.009 Standards applicable to specific areas
4	A. Resolution of standards conflicts. To the extent there is a conflict between this
5	Section 23.47A.009 and other sections of Title 23, the provisions of this Section 23.47A.009
6	apply.
7	***
8	E. Reserved.
9	F. Ballard Hub Urban Village. The following provisions apply to development
10	proposed in NC zones within the Ballard Hub Urban Village.
11	1. Maximum lot coverage on lots 40,000 square feet in size or greater.
12	a. The maximum lot coverage permitted for principal and
13	accessory structures is 80 percent of the lot area.
14	b. Lot coverage exceptions. The following structures or portions of
15	structures are not counted in the lot coverage calculation.
16	1) Portions of a structure that are below grade or that do not
17	extend more than four feet above the finished grade.
18	2) The first 18 inches of overhead horizontal building
19	projections of an architectural or decorative character such as cornices, eaves, sills, and gutter,
20	3) Ramps or other devices that provide access for the
21	disabled and elderly and that meet the standards of the Seattle Building Code,
22	4) The first four feet of unenclosed porches or steps for
23	residential units.

1	c. At least 20 percent of the lot shall be improved as follows:
2	1) Provide elements at-grade that enhance the usability and
3	livability of the lot for residents and tenants such as pedestrian circulation areas, landscaping,
4	lighting, weather protection, art, or other similar features;
5	2) Include portions that are visible from abutting rights-of-
6	way or adjacent public open space; and
7	3) Include not more than 10 surface parking spaces.
8	2. Facade modulation
9	a. Facade modulation requirements apply to all portions of a
10	structure up to a height of 45 feet located within 10 feet of a street lot line, according to
11	provisions of Subsection 23.47A.009.F.2.c.
12	b. The maximum width of any unmodulated façade is 100 feet.
13	Façade widths shall be modulated at 100 feet intervals by stepping back the façade from the
14	street lot line for a minimum depth of 10 feet and a minimum width of 15 feet.
15	c. Façade modulation requirements do not apply to portions of a
16	structure that are below grade or that do not extend more than two feet above the finished grade
17	at the lot line.
18	3. Maximum structure width
19	a. The maximum allowed structure width is 250 feet.
20	b. Structure width limits do not apply to portions of a structure that
21	are below grade or that do not extend more than two feet above the finished grade at the lot line.
22	4. Setback requirements
23	a. Street level setbacks.



1	1) In the area shown on Map D for 23.47A.009.H, portions
2	of a structure up to 10 feet above the abutting sidewalk grade facing 15 th Avenue NW shall be set
3	back from the street lot line by a minimum depth of 6 feet up to a maximum depth of 10 feet.
4	2) Setback areas may contain wider sidewalks, plazas,
5	landscape features, or other open space.
6	b. Upper level setbacks.
7	1) A setback with an average depth of 10 feet from abutting
8	street lot lines is required for portions of a structure above a height of 45 feet. The maximum
9	depth of a setback that can be used for calculating the average setback is 20 feet.
10	2) A setback with an average depth of 15 feet from abutting
11	street lot lines is required for portions of a structure above a height of 65 feet. The maximum
12	depth of a setback that can be used for calculating the average setback is 25 feet.
13	5. For lots 40,000 square feet in size or greater the requirements contained
14	in Sections 23.47A.009.F.2, 23.47A.009.F.3, and 23.47A.009.F.4.b, may be waived or modified
15	only if one or more of the following features are provided to offset the bulk of the project:
16	a. A usable open space that abuts the street, is no more than four
17	feet above or four feet below the adjacent sidewalk grades, has a minimum width equal to 30
18	percent of the width of the street-facing facade or 20 feet, whichever is greater; and a minimum
19	depth of 20 feet measured from the abutting street lot line.
20	b. A separation between structures that serves as a north-south
21	through-block pedestrian passageway, a woonerf that is approved through a design review
22	process pursuant to Chapter 23.41, an approved amenity area, or a combination thereof; has a

minimum width of 20 feet; and is no more than four feet above or below the adjacent sidewalk grades. 6. Structures permitted in required setback and separation areas according to subsections 23.47A.009.H are subject to subsection 23.47A.014.F.
