#### **Executive Summary**

In early 2006, Seattle Mayor Greg Nickels asked his staff to convene a group of community and business leaders, service providers, and residents of South Park to launch an effort called the South Park Action Agenda. The South Park Action Agenda document is a product of a community- driven, city staffed effort to develop a neighborhood vision and the specific strategies and recommendations for achieving that vision. The Action Agenda is broken down into five main issue areas: Youth Development, Environment and Physical Improvements, Community Engagement, Business and Transportation, and Public Safety. Teams of neighborhood residents, business representatives, community leaders and service providers formed committees for each issue area, and over a 6 month period developed a series of strategies and recommendations that are collectively called the South Park Action Agenda.

The development of the South Park Action Agenda involved the community review of old planning documents, identified new and emerging community challenges and opportunities, and identified neighborhood priorities. They also engaged in an extensive community survey process to ensure that their recommendations were reflective of the entire neighborhood.

The South Park Action Agenda strategies and recommendations are founded on a neighborhood vision that prioritizes strong and healthy families, a thriving business district, a safe, environmentally friendly and visually attractive community, a strong sense of community identity, and genuine appreciation of the neighborhood's diversity.

The South Park community will deliver their Action Agenda to Seattle Mayor Greg Nickels in October 2006. Action Agenda strategies and recommendations will be implemented over a number of years through partnerships with the City of Seattle, South Park service providers, community members, local industries and businesses, as well as non profits and foundations.

#### How to Read this Report

The South Park Action Agenda strategies and recommendations are listed in no particular order, as the community feels that they are all important. The only exceptions are the 10 priorities listed below.

This report is supported by the 1998 South Park Urban Village Neighborhood Plan, a neighborhood surveying effort, and a youth forum and survey. These supporting documents are referenced throughout the Action Agenda in footnotes or via supportive statistical statements located in the margins. In addition, the committees found that many of the recommendations in different committees are supportive of one another and wanted the document to reflect this. Therefore, many of the recommendations are followed by italicized, bolded references to recommendations located elsewhere in the document. The same recommendations are also cross listed in an attached matrix.

The statistical statements locate in the margins also reference specific survey questions and results, which are also attached to the end of this document.

Also, an acronym chart of city departments and neighborhood organizations has also been created and attached to this document.

Finally, each recommendation lists city departments, South Park providers, non profits, foundations, businesses, organizations, and other partners that are anticipated partners to implement the specific recommendations. It is important to note that these are only anticipated partners that may shift or change during implementation depending on unforeseen circumstances or factors.

#### Overview

In the summer of 2005, Mayor Greg Nickels expanded the City of Seattle's efforts to create trust and partnership with the South Park community. Successes from those efforts, especially the funding of gang prevention and intervention services, the Department of Social and Health Services' agreement to provide services to South Park residents from its White Center office instead of southeast Seattle, as well as the opening of the South Park Library on Cloverdale Street, laid the groundwork for another phase of work in this community: The South Park Action Agenda.

Beginning in April 2006, a group of community and business leaders, community- based organizations, residents and youth worked with city staff to develop the South Park Action Agenda (SPAA). The South Park community agreed to break into five committees to develop specific strategies and recommendations in these areas:

Youth Development Environment and Physical Improvements Community Engagement Business and Transportation Public Safety

The committees began their work in May 2006. Each committee was chaired by a South Park resident and staffed by a "team lead" from the city. In addition, the Youth Development Committee was co-chaired by two South Park youth.

#### South Park Neighborhood Background

South Park is one of Seattle's most diverse and historically interesting neighborhoods. Today, with some 3,000 residents, South Park's demographics are unlike those found in any other neighborhood in the city: approximately 37 percent of the residents are of Hispanic origin, compared to 5.3 percent citywide. There are also residents who are Caucasian (roughly 50 percent), as well as small percentages of African-Americans and Asian Pacific Islanders, among other nationalities. Eleven percent of the neighborhood lives in poverty, and 89 percent of the students at the local elementary school qualify for free or reduced-fare lunches. Unlike the citywide average of nearly 90 percent of people over age 25 having completed high school, in South Park that figure is approximately 33 percent. Moreover, services must be sought outside of the neighborhood: there is no post office, full-service grocery store, bank, or neighborhood service center in South Park, and there are inadequate public transportation options connecting South Park with other neighborhoods where services can be found. Violence and crime has also plagued the neighborhood, with an increase in gang-related activity and gun violence in recent years<sup>1</sup>.

At the same time, the past few years have seen the people of South Park band together to address critical community issues, such as violence and crime prevention, public health and the environment, community and economic development, and youth education and participation. The South Park Action Agenda built on this positive climate of inclusion and participation by engaging in an extensive survey process that provided valuable insights from community members who had never before been involved in developing community strategies. The South Park Action Agenda recognizes and is enhanced by the importance of diverse resident participation in the development of strategies and recommendations for the neighborhood.

#### **Context for Community Report**

The South Park Action Agenda is the result of an intensive community-driven neighborhood assessment and strategy effort that aims to bring the South Park neighborhood vision to fruition. The strategies are organized by committee into short-term (two to three years), mid-term (three to five years), and long-term (more than five years) recommendations. The recommendations require the participation of multiple parties for implementation, including the city, county, state, federal government, and most importantly, the community itself.

South Park Action Agenda committee members volunteered more than 1000 hours of their time to formulate this report. While developing the Action Agenda recommendations, committee members agreed their work would benefit from additional community input that would reflect the neighborhood demographics. The committees drafted survey questions and worked with a consultant, PolicyLink, to develop an extensive survey that was translated into Spanish and Cambodian. A principal goal of the survey was to reach Latino and Asian Pacific Islander community members who had had little or no contact with the South Park Action Agenda process.

Committee members, supported by city staff and resources, engaged in an extensive outreach process to reach deep into the South Park community in a series of "living room forums." Several South Park residents hosted gatherings in their homes, attended by neighbors. The groups discussed neighborhood issues and completed the neighborhood survey. City staff also attended regularly held community events and asked community members to complete a shortened, "street version" of the survey. Finally, the "street version" of the survey was posted online and advertised to the South Park list serve.

This process yielded a total of 227 surveys (111 long, 82 street, and 34 online). Overall, 46 percent were completed by Latinos, and 54 percent were completed by English speakers. Comparatively, the 2000 Census shows the Spanish speaking population at 26 percent, and the English speaking population at 54 percent. No

Cambodian surveys were completed. The survey received an enthusiastic welcome from those who responded and underscored the importance of offering a variety of ways for community members to get involved.

In addition, the Youth Development Committee included four youth leaders who initiated, organized, and facilitated a youth forum where a diverse group of 40 teenagers completed S PAA Youth Forum written surveys, participated in small group discussions, and enjoyed socializing with each other at the South Park Community Center. Information gathered from the these activities validated the needs voiced by committee members, reinforced feedback from previous youth forums and planning documents, and is included in the SPAA Youth Development recommendations.

The neighborhood surveys were collected and analyzed while recommendations were still being formulated. Designed to reach residents who had not yet been involved in the Action Agenda, the analysis ultimately validated and supported the recommendations defined by the committees. While not every aspect of the recommendations that follow was addressed in the survey instruments, portions of the analyses have been incorporated into some committee recommendations. In addition, the more detailed results of the analysis are attached and should be considered as recommendations are implemented.

The committee members have also taken advantage of mutually supportive recommendations across committees which are noted throughout the document. A matrix of these specific recommendations is also attached and provides further evidence of the synergy between committees and the overall document.

The South Park Action Agenda is a document that is a true reflection of this neighborhood's priorities and vision for the near and distant future. It offers carefully crafted strategies and recommendations that are fundamentally supported by the diverse community. Finally, this document is a testament to this community's strength and dedication to their neighborhood, and gives enormous insight to the phrase "South Park Pride."

#### South Park Vision

The following vision statement is derived from the vision statement in the South Park Residential Urban Village Plan of 1998 and the brainstorming of committee members during the 2006 Action Agenda process. It is an aspirational, nonbinding statement describing the South Park of the near and distant future.

- We envision South Park as a community:
- With a thriving retail core surrounded by pedestrian-friendly residential and industrial uses that together create a welcoming and safe environment;
- Served by a sound South Park Bridge and characterized by clean and well maintained roads, sidewalks, and other public facilities;
- Where residents and businesses feel safe, secure, and comfortable on foot, bicycle, or utilizing the fast and frequent modes of public transportation available to them;
- Where children and youth feel safe and enjoy a broad array of recreational and scholastic opportunities, using a variety of public and private facilities;
- Where residents and businesses are encouraged to interact often and are fully engaged in community-level decision -making that is well served by a coordinated network of nonprofit and community organizations;
- That actively promotes and celebrates cultural and ethnic diversity, fosters new and emerging leadership, and deliberately cultivates a community environment that prioritizes acceptance and inclusiveness;
- Where residential, commercial, and industrial interests are considered on an equal basis to create a pleasant living environment, abundant job opportunities, and successful, environmentally responsible community;
- That takes pride as Seattle's only riverfront village, practices responsible stewardship of the river, and supports a variety of commercial, industrial, recreational, and wildlife uses along the river;
- Where the detached family house is the dominant housing style and both owners and renters feel a sense of neighborhood pride and stewardship; and
- Where residents and businesses have a collaborative and positive relationship with fire and public safety departments and so are well prepared to solve problems and respond to emergencies as needed.

#### Summary of South Park Community Goals

- 1. Youth Development: Create and maintain a vibrant South Park community that provides unlimited opportunities for youth and families to thrive.
- 2. Environment & Physical Improvements: Seek a variety of improvements designed to improve the quality of life in South Park, promote economic development, and protect public health and safety.

- 3. Community Engagement: Create and maintain a neighborhood where all community members feel welcome, are informed and educated about the decisions impacting the neighborhood, and have a voice and vote in the decision making process. Educate and train community members and providers so they are able to outreach to residents in a language appropriate and culturally competent manner. Create and maintain an environment where the great diversity, culture, history and traditions of South Park residents are valued and appreciated.
- 4. **Business and Transportation:** To create and maintain a neighborhood where frequently purchased items are available in the neighborhood; where there is robust access to mass transit or an alternative to driving into and out of South Park; and where there is a successful industrial sector.
- 5. Public Safety: To ensure a neighborhood in which the community can safely live, do business, and interact with others, now and for generations to come. Must be founded on a cohesive community that is engaged, empowered, and focused on common goals and priorities.

#### South Park Action Agenda Priorities

- Replace the South Park Bridge. Government entities, elected officials, the community and business organizations work to obtain funding for the South Park bridge. Possible funding sources are King County, Puget Sound Regional Council, Regional Transportation Improvement District, Washington State Department of Transportation, City of Tukwila, City of Seattle, U.S. Federal Highway Administration, and private foundations.
- 2. Build upon current efforts to combat crime by enhancing safety and security thereby encouraging the continued investment in our retail, industrial, commercial, high density, and residential properties.
- 3. Implement the South Park drainage plan and improve substandard streets in the commercial, residential and industrial sectors.
- 4. Increase capacity of existing facilities and add facilities to meet South Park's educational, recreational, social and cultural needs.
- 5. Sustain, enhance, and increase programs that support positive youth development and strengthen families. Strong community and provider partnerships combined with committed city resources are required for success.
- 6. Continue to focus on and foster improvement of the environmental health of South Park.
- 7. Create and maintain a neighborhood where all community members are informed and educated about the decisions impacting the neighborhood and they have a voice and vote in the decision making process. Educate and train South Park community members and providers so they are able to outreach to residents and businesses in a language appropriate and culturally competent manner.
- 8. Engage community members and providers in formal planning processes and other civic engagement activities by providing interpretation services, translation of written materials, and creating welcoming environments appropriate to the cultures represented. Requests to have meetings provided in a group's primary language should be responded to and honored whenever possible.
- 9. Ensure diverse South Park resident representation on advisory boards, committees, and panels.
- 10. Use the Community Engagement Committee's vision statement to guide the execution of the implementation phase of the South Park Action Agenda.



#### **SECTION 2: ENVIRONMENT AND PHYSICAL IMPROVEMENTS**

Vision: Seek a variety of improvements designed to improve the quality of life in South Park, promote economic development, and protect public health and safety.

#### Strategies:

2.1 Make South Park drainage improvements a top priority for the City of Seattle. Design and implement drainage improvements as follows<sup>11</sup>:

#### **Short-Term Recommendations**

- a. Design and construct Middle Basin flooding and water quality improvements (Middle Basin is the area south and west of Concord Elementary and north and east of Marra Farm) (SPU)
- b. Design and construct pump station (end of Seventh Avenue South at Duwamish River). Pump station critical to reduce flooding - will pump excess stormwater primarily from Lower Basin of South Park (Lower Basin is industrial area west of Duwamish River, east of SR99, and roughly bounded by South Webster to the north and South Southern to the south) (SPU)
- c. Begin evaluating drainage fixes in Lower Basin of South Park 12 (SPU)
- d. Work with SDOT and SPU regarding drainage needs for SDOT's repaving project along 14th Avenue South in the business district (SDOT, SPU)
- e. Study feasibility of near-term flooding improvements at 1) Concord and 12<sup>th</sup> Avenue South, and 2) South Riverside Drive. Results of analysis will determine if construction will occur. (SPU)
- f. Survey businesses in the lower basin where problems have been identified to determine the extent of drainage problems<sup>13</sup> in Lower Basin. (SPU) This will consider challenges and potential limitations of near- and long-term drainage improvements, such as tidal influence, and existing infrastructure (utilities, homes, businesses, etc.). The improvement plan for the Lower Basin will also need to be consistent with the community's overall vision for South Park (SPU)
- g. SPU shall initiate work to define improvements to the lower basin. This will consider challenges and potential limitations of near- and long-term drainage improvements such as tidal influence, and existing infrastructure (utilities, homes, businesses, etc.). The improvement plan for the Lower Basin will also need to be consistent with the community's overall vision for South Park. (SPU)
- h. Support needed funding for River City Skatepark for construction and operation of the facility (Sea Mar, Community, developer, Parks)
- 2.2 Improve both the quality and quantity of open space, providing places for residents to interact, recreate, play, view, picnic, and gather<sup>14</sup>.

#### **Short - Term Recommendations**

- a. City supports Port's development of Eighth Avenue street end park (Port, DPD, OED, SPU)
- b. Support clean up of Terminal 117 as "Accessible Habitat" and include clean up of Basin Oil site in the plan (Ecology)
- c. Support needed funding for Cesar Chavez Park for hardscape art, trellis and bus shelter. (\$150K state grant will cover art but not trellis and bus shelter) (Metro, King County, Seattle Parks) *Supports Community Engagement Strategy 3.3*
- d. Review or create inventory of areas where street end improvements might be possible/desirable in South Park (SPARC, Friends of Street Ends, SDOT)
- e. Complete Duwamish bike trail by continuing bike lane on Eighth Avenue South (??) and connecting to Catholic Hill trail. Maintain, widen (to accommodate bicycles) and add lighting along Catholic Hill trail (from Eighth Avenue South to Henderson Street pedestrian bridge). Ensure bike trail and facilitation of bicycle riding is sensitive to needs of truck traffic and pedestrians. (SDOT, DOC, DOE, King County Conservation District)<sup>15</sup> Supports Business and Transportation recommendation 4.7c

2.3 Support completion of the South Park Marra Farm Coalition Master Plan which is based on community and Marra Farm coalition input. Fund implementation of the plan's recommendations that will likely include the following elements:

#### **Short-Term Recommendations**

- a. Construct new fencing around agriculture areas, which is welcoming to the public, but helps minimize theft and entry by dogs (Parks, Marra Farm Coalition, King County)
- b. Provide a farm-themed and "natural" play area to maximize imaginative play and to maintain the concept of a working farm in harmony with nature. At the community meetings, keeping the play area as natural as possible was felt to both maximize imaginative play and complement the concept of a working farm in harmony with nature (Parks, Marra Farm Coalition, King County)

- d. Provide Perimeter Paths: ADA accessible nonconcrete paths through and around the garden. Accessibility must be tempered by recognition of volunteer groups' maintenance ability and by future needs of farm operations<sup>20</sup> (Parks, Marra Farm Coalition, King County)
- e. Install and maintain a composting toilet or an alternative sewage conveyance (Parks, Marra Farm Coalition, King County)
- f. Develop a Memorandum of Understanding between Parks and the Marra Farm Coalition that addresses maintenance and operations, as well as other shared concerns(Parks, Marra Farm Coalition, King County)

#### **Mid-Term Recommendations**

- g. Create the "Hill" picnic area another key welcoming area for the public, which would clean up the Director Street side of the Fibers property. Plant large caliper trees that will as soon as possible ease reliance on existing mature cottonwood trees (Parks, Marra Farm Coalition, King County)
- h. Construct the framework of the site according to concept design preferred by the Marra Farm Coalition, which includes-major paths, terracing, major plantings(Parks, Marra Farm Coalition, King County)
- i. Construct a covered central gathering area with large pavilion (Parks, Marra Farm Coalition, King County)



43% of survey respondents would prefer that Terminal 117 be converted to a park or open space. (survey question 28A)

#### **Long-Term Recommendations**

- k. Retain and manage the Cottonwood trees while new plantings mature (Parks, Marra Farm)
- I. Focus on the natural/recycled/environmentally friendly aesthetic in all design improvements to the site. Maintain the organic feel to the farm (minimizing hard angles, concrete, use of plastics, etc.) (Parks, Marra Farm Coalition, King County)
- 2.4 Improve the health of the Duwamish River, and enhance community opportunities to experience the river through beautification, improved fish habitat, public health, economic development efforts

#### **Short-Term Recommendations**

- Support clean up of Terminal 117 as "Accessible Habitat" and include clean up of Basin Oil site in the plan. Support naming of it after the late John Beal (Ecology)
- b. Help fund a DRCC-led comprehensive map showing current public access, fish habitat improvements, open space, and other amenities along the river<sup>21</sup> (SPU/SCL Superfund team)

The Duwamish River was noted by many respondents as something they like about South Park. (survey question 7)

Survey respondents frequently noted how unclean and badly maintained their neighborhood is. Ugliness/ lack of cleanliness are among the top five of things they don't like about South Park

- b. Improve traffic signal timing and facilitate westbound traffic from northbound 14<sup>th</sup> Avenue South with a left-turn signal should not require a new turn lane, just a reconfiguration of the traffic signal (SDOT)
- c. Explore potential for sidewalks to connect Concord Elementary to Marra Farms to community center (SDOT)
- d. Complete pedestrian lighting begun in 2004 along Cloverdale between 14<sup>th</sup> Avenue South and Fifth Avenue South, install pedestrian lighting on Eighth Avenue South, lighting at community center playfield, tennis courts and children's play area (SCL, SDOT) *Supports Youth Development recommendation 1.1k and Public Safety recommendation 5.1e*
- e. Prune the trees on 12<sup>th</sup> Avenue South between Sullivan and Dallas to light the street for pedestrians (SDOT)
- f. Reconfigure South Concord between 14<sup>th</sup> Avenue South and 12<sup>th</sup> Avenue South and between 15<sup>th</sup> Avenue South and Boeing facility area is currently an asphalt ocean without clear delineation between pedestrian, traffic and parking areas. Flooding problems here as well (SDOT, SPU)
  - 1. Reconfigure to make clear boundaries of street and shoulders (SDOT)
  - 2. Build curbs and sidewalks (SDOT)
  - 3. Plant street trees (SDOT)
  - 4. Improve drainage in the intersection to fix flooding problems (SDOT, possibly SPU)
- g. Install alternating pedestrian lights and South Park banners along walkways to increase public safety, and promote pedestrian movement through the community<sup>24</sup> (SCL, OED) *Supports Public Safety recommendation 5.1e* 
  - Along 500 block of Sullivan.
  - Fifth Avenue South from Cloverdale to Marra farm.
  - Seventh Avenue South from Cloverdale to Concord School and to Marra farm.

  - Henderson from 5<sup>th</sup> Avenue South to 14<sup>th</sup> Avenue South

- j. Implement traffic management measures in transitional residential//industrial areas to improve truck circulation and local access to regional facilities and minimize significantly truck impacts in the following areas<sup>25</sup> (SDOT):
  - Eighth Avenue South, north of South Director Street to South Cloverdale Street
  - Eighth Avenue South/Ninth Avenue South, south of South Cloverdale Street to State Route 99
  - 3. Fund and implement community requested and Seattle Department of Transportation produced plan for improvements at Eighth Avenue South and South Director Street (Greater Duwamish MI Center Approval and Adoption Matrix, reference # TP-30, O and M)



Survey respondents feel that better lighting is secondmost important thing for improving safety in South Park.

- k. Explore potential for bike path connecting Concord Elementary to Marra Farm to Civic Center, Community Center, Neighborhood Center and 14<sup>th</sup> Avenue South business district<sup>26</sup> (SDOT)
- I. Work with Department of Corrections and/or other crews and city programs to clear and maintain areas of South Park that are overgrown with ivy and other invasive plants. Committee will identify specific areas in addition to:
  - 1. Area around stairs at 10<sup>th</sup> Avenue South and Trenton Street (SDOT)
  - 2. Area around stairs at 12<sup>th</sup> Avenue South and Trenton Street (SDOT)
  - 3. Cesar Chavez Park (Parks)
  - 4. Pedestrian walkway from Eighth Avenue South to South Henderson Street (WSDOT)
  - 5. Rivercity Skate Park (Community)
  - 6. Marra Farm (Parks)
  - 7. Areas to be reforested along State Routes 99/599 and 509 (WSDOT)
  - 8. Replace rusty fence guard on Henderson pedestrian overpass of State Route 99 with artistic metal work, as in South Lake Union area.
- Replace rusty fence on Henderson pedestrian overpass of 99 with artistic metal work like in South Lake Union are (WSDOT)

#### **Long-Term Recommendations**

- n. Pave, improve, and add speed bumps where appropriate in the following alleys (Community: Adjacent property owners and/or developer) *Supports Public Safety recommendation 5.1f:* 
  - 1. Alley between Fifth Avenue South and Seventh Avenue South and Sullivan and Cloverdale Streets
  - 2. Alley between Fifth Avenue South and Seventh Avenue South and Cloverdale and Donovan Streets
  - 3. Alley between 12<sup>th</sup> Avenue South and 14<sup>th</sup> Avenue South and Sullivan and Cloverdale Streets
  - 4. Alley between Eighth Avenue South and 10<sup>th</sup> Avenue South and Cloverdale and Sullivan Streets
- o. Facilitate safe industrial traffic <sup>27</sup> (SDOT):
  - 1. Facilitate wide truck turns with vehicle setback boundary lines at stop sign and signaled stop areas.
  - 2. Install signs prohibiting vehicle parking within 30 feet of stop signs.
  - 3. Designate a "no parking" zone at 10<sup>th</sup> Avenue South and Kenyon Street at curved corner (dangerous spot for trucks, cars)
  - 4. Facilitate truck traffic by developing safe bicycling routes (See Strategy 2.2)
  - 5. Install "children at play" signs on residential streets
  - 6. Install speed control measures, such as cameras and signs on 14<sup>th</sup> Avenue South.
- p. Facilitate safe traffic by developing and implementing speed control strategy/ measures on 14th Avenue South, especially coming toward and off of the South Park bridge<sup>28</sup> (SDOT)

- f. Install pedestrian guardrail along sidewalk under bridge. Design can be influenced by metal work at Cesar Chavez Park (SDOT or WSDOT)
- g. Install artwork on utility poles along Eighth Avenue South and South Cloverdale Street to the river (SDOT, Qwest, SCL)

- e. Provide funding for a new demographics report for marketing and investment purposes<sup>33</sup> (OED ECOSS grant) Supports Community Engagement recommendations 3.1d, 3.1I, and Business and Transportation recommendations 4.2a, 4.3b, 4.3c
- f. Target crime against South Park businesses *Supports Business and Transportation* recommendation 4.4a, Public Safety recommendation 5.1b
  - 1. Implement a Business Watch program (SPD)
  - 2. Promote safety through environmental design in business district (SPD, OSE)
  - 3. Support/fund youth, teen and family education campaign (HSD, SPD)

#### Mid-Term Recommendations

g. Incorporate a public promenade and commercial development into the bridge property development. Create and execute visioning process with community<sup>34</sup> (Community, King County, developers)

- d. Provide funding for youth development in collaboration with local business and industry in South Park (HSD)
- e. Provide support for partnerships between SPARTS, Concord Elementary School and South Park Community Center to:
  - 1. Create a Resident Artist in the Schools program (OACA)
  - 2. Facilitate arts appreciation in the youth of South Park through neighborhood artist-youth mentoring projects (OACA, DON) *Supports Youth Development recommendation 1.5b*

#### Mid-Term Recommendations

- f. Support development of a South Park Center for the Arts in the business district, which would provide (OACA, OED, Community):
  - 1. Studio space for local artists
  - 2. Classroom space for community outreach and arts awareness
  - 3. Gallery space for local artists
  - 4. Paid gallery and classroom staffing

### 2.10 Facilitate annexation process and support South Park Bridge improvements (Supports Business and Transportation Strategy 4.6, Public Safety recommendation 5.1h)

#### **Short- Term Recommendations**

- a. City of Seattle takes an active role in the regional effort to obtain funding for the South Park Bridge (OPM)
- b. The city negotiates with King County immediately to separate the bridge issue from the annexation process (OPM)

 Catholic Hill - Support development of Catholic Hill as multifamily duplextriplex Lowrise Duplex Triplex (LDT). This helps satisfy neighborhood plan item of providing low-income and affordable housing through market-rate housing production (DPD, OH)<sup>39</sup>

Location and affordability are the top two reasons why South Park survey respondents have chosen to live in South Park. (survey question 3)

- b. Industrial zoning (DPD)
  - 1. Provide visual and sound barriers such as trees for already- developed sites in the industrial buffers zones between residents and industrial areas (DPD and/or SDOT)
- c. Cloverdale Street South rezone (DPD, OH) Support re-zoning 1200 block of Cloverdale to L2/RC from SF5000 to allow for commercial-residential mixed use (three stories should be height limit in SP)<sup>40</sup> Supports Business and Transportation recommendation 4.3g
- d. SPAA acknowledges existing duplex-triplex-quadplex housing and supports this kind of housing on arterials (DPD, OH)
- e. SPAA encourages preserving residential land for residential use and for mixed use (residential-commercial) development on arterials with a goal of maintaining or increasing housing density (DPD, OH)
- f. SPAA encourages the city to support efforts of organizations that promote affordable housing, such as Homesite and Habitat for Humanity<sup>41</sup> (OH, foundations and non-profits)
- g. Seek approval for zoning change to allow use of detached accessory dwelling units (DPD)
- h. Infrastructure for L-3 zoning on Cloverdale Street South (SDOT)
  - 1. Install concrete alley in and abutting this zone (Community: Adjacent property owners and/or developer)



Vision:



Educate and train community members and providers so they are able to outreach to residents in a language appropriate and culturally competent manner. Create and maintain an environment where the great diversity, culture, history and traditions of South Park residents are valued and appreciated.






#### 4.8 Improve and maintain freight and car mobility with street improvements

### **SECTION 5: PUBLIC SAFETY**

Vision:

To ensure a neighborhood in which the community can safely live, do business, and interact with others, now and for generations to come. Must be founded on a cohesive community that is engaged, empowered, and focused on common goals and priorities.

#### **Strategies**

#### 5.1 Prevention

#### **Short-Term Recommendations**

- a. Increase the number of block watch programs in South Park. Encourage interaction and engagement of the community in culturally and language appropriate ways (Community, SPD) Supports Youth Development recommendation 1.4b, Community Development recommendation 3.4a

#### Appendix B 1

#### South Park Survey Analysis Courtesy of PolicyLink

This analysis is based on a survey conducted during the months of July and August in the South Park neighborhood of Seattle, Washington. The survey was intended to supplement the South Park Action Agenda, a community planning document that will influence short- and long-term investment into the neighborhood by the City of Seattle and other potential investors. This analysis is based on surveys received by close of business on Thursday, August 17, 2006. As a result the sample size was drawn as follows:

#### 227 total respondents

- 111 long form surveys [61 questions, multiple choice and open ended]
- 82 short form surveys [25 questions, multiple choice and open ended]
- 34 online surveys [based on the short form]

In keeping with objectives of process, particular attention was given to reaching Latino communities during the survey outreach. The survey is suspected to have had no fewer than 105 respondents self-identified as Latino. Because of the method of survey capture – at events, person-to-person, and in living room forums hosted at neighbors' homes, there is a high degree of confidence of the ethnic breakdown despite not having a question tracking this data on the form. Greater outreach remains to reach other communities not represented well in the mainstream.

These surveys were richly supplemented by direct outreach by volunteers to the planning process, conversations with individual youth in the neighborhood, and informal outreach at community events during July and early August.

#### **Universal Findings**

The South Park Assessment was developed in response to a pressing community need – to incorporate the participation and perspective of the neighborhood's growing Latino population into a planning effort that was already well under way. The Assessment was conceived, developed, and executed in an exceptional effort under tight timeline and pressure. It represents a potential model for subsequent administrations or other communities to consider for acquiring useful intelligence on community need. Some of the overarching findings follow.

**Mission Accomplished.** A principal goal of the survey was to reach Latino community members whom had little or no contact with the SPAA process; through outreach techniques applied, high confidence that more than 50 percent of respondents were from that constituency. Further, the outreach process to these communities made scores of additional residents aware of the process.

**Enthusiastic Response.** Despite the extensive nature of the survey, the response rate was impressive. More than 85% of survey queries on surveys collected were completed. Responses were specific and thoughtful.

**Sample Size.** At 227 responses in a neighborhood of X,500, the results from the survey may prove sufficient to trend, but not to draw thorough conclusions. It also provides insight that leads to recommendations for further outreach.

An Insightful Community Process. Although the findings underscore that significant segments of the community need additional outreach, it also validated the hard work of the South Park Planning Process. There were no major surprises in the concerns of residents or in the desires for the future for their community. The priority concerns of residents unconnected to the Action Agenda in large part are reflected in the priorities addressed in the existing plan. While those respondents missed an important moment in South Park Planning,

**Momentum.** People are willing to get involved if they can see a deliberate and well-conceived strategy to make something happen. Next steps need to capitalize this interest quickly.

#### Life in South Park

Nearly 61 percent of respondents live in South Park, and 21 percent work there. A significant percentage of respondents visit the neighborhood (19.8%), which reflects the nature of survey outreach.

- On balance, respondents were long-term residents of the neighborhood. Of respondents claiming residency. 64.9
  percent of Latinos and 71.3 percent of others have lived in the neighborhood more than 2 years, and nearly 40
  percent of all respondents have lived there longer than 5 years.
- Homeownership patterns diverged significantly by the two sample groups. While three-fifths of non-Latino
  respondents owned their homes, barely one-fifth of Latino respondents did so.
- South Park is well located, affordable, and has character. 26.6 percent cited location as a principal reason for living there, and 27.3 percent cited its affordability.

#### **Community Spirit**

There was overwhelming sense of community sprit apparent among respondents. Even accounting for the fact that those who would take the time to fill out the survey might have more interest in community issues, the rate at which people responded they felt like a part of the community – more than 83 percent – was impressive. There were consistent reasons people felt that

way. Among them were family, cultural diversity, neighborhood character, and a strong sense of family. Specific reasons included:

- · Friends and family live near by
- · Length of stay in neighborhood
- Healthy relationship with neighbors
- Neighborhood has many cultural events
- Diverse neighborhood- multicultural, strong Latino community
- Access to bilingual (Spanish/English) services and activities
- Strong civic institutions- libraries, parks, schools, South Park Community Center

There are several things people would like to see that would build a sense of community in South Park:

- Access to retail services of diverse scopes, from boutique and neighborhood serving establishments to major chains and clothiers
- More neighborhood interaction, such as block parties, community centers, and events
- Recreation and leisure cafés, swimming pools, open space, and youth activities

# **Business Development Opportunities**

The majority of respondents frequent neighborhood businesses. 81 percent of the respondents either use local businesses frequently or occasionally, with barely ten percent saying that they do not utilize the businesses. Other findings:

- There are differences of opinion about the most desirable direction for retail development. Some respondents would like to see more major retailers (Starbucks, Target, Wal-Mart); others favor more locally-based grocery stores, cafés, and similar amenities. There is a strong desire for more ethnically-focused retail, such as Latino markets.
- Other needs include Laundromats, bookstores, and pharmacies.

## Perspectives on Youth Services in South Park

Overall, respondents felt that the neighborhood is generally youth friendly, citing a great community center, green space, sports activities and family oriented activities. Those who didn't feel the neighborhood embrace youth cited insufficient youth-oriented activities, as well as continuing problems with delinquency, gang activity, and drugs

- Schools and after school programming were listed as high priorities, with traffic control and pedestrian safety listed as moderately important.
- Services in Spanish, culturally competent programming, colleges, and mentoring programs were also listed as important priorities
- About 50% of respondents did not have their children in youth programming, many of whom were not aware of neighborhood programs available to their children, a crucial factor in considering future programming.
- A slightly higher percentage of English speaking respondents had their children in available programs than their Spanish-speaking counterparts (28 to 22 percent). Several respondents commented that information on youth activities is frequently not available in Spanish.
- Only 24.3 percent of respondents stated that their children participated in programs, and very few responded with names of specific programs or places their kids go. Of the few that were mentioned, sports, after school programs and the South Park Community Teen Center were highlighted.

#### **Challenges Confronting South Park**

Despite the high level of community spirit present among respondents, several issues were identified as areas for further improvement.

**Public Safety.** There is a definite perception that public safety is an issue, specifically among Latino respondents. Overall, 51 percent responded that the neighborhood was not safe, but when among Latinos, that figure jumps to 59 percent (versus 45 percent of others). Respondents cited crime, drug- and gang-related activities, and prostitution as the biggest problems in South Park. Other responses include:

- Lack of diversity in local leadership
- Deteriorating housing stock
- Pollution, poorly maintained city streets. South Park residents responded quite favorable to the last physical
  improvement project, a signage program instituted some months ago. The appetite appears high for the next
  iteration.
- Racial profiling by police

**Transportation.** Transportation remains a source of consternation for many transit dependent residents in the neighborhood. Only 29.5 percent of respondents found public transit adequate, a figure that was consistent across all categories. This is an important issue as automobiles are not the only method of transit for South Park residents, especially within the community. Other preferred (or required) methods of transportation include bicycling, walking, and ride sharing. There were numerous qualitative suggestions on how to improve transit access, including specific corridors where route frequency could be improved.

**Infrastructure.** While many respondents were not familiar with the notion of considering all of these issues in the same breath, infrastructure issues remain a high priority. In a series of questions designed to test the chief infrastructure concerns, sidewalks, road improvements, intersections, drainage, and air quality all ranked highly. The most pressing concern based on a write-in question was road repair, bridge replacement, and pollution reduction.

# The South Park Action Agenda Process

Visibility of the Action Agenda was mixed. While 33 percent of respondents were aware of the process, the level diverged greatly in different communities. Young people and Latinos were much less likely to know about the process among those who responded to the survey (18.4 percent of Latinos versus 51.3 percent of others). One on hand, this is to be expected as the idea was to reach people who had been outside of the process. That said, the gap in awareness indicates that there should be further research on why the word was not penetrating deeper into these communities. Other findings:

- If language, childcare, and scheduling can be addressed, 67.9 percent of the barriers identified by respondents would be resolved.
- Only 10.6 percent of respondents cited a lack of interest as a barrier to involvement.
- Of those who claimed there were not aware of the process or unsure if they had heard about it, 67.2 percent said that given the opportunity that they would get involved. [note: this was a long form query only]
- A diversity of strategies will be necessary to attain full participation. Given seven options for how to improve
  participation, each of the choices received at least 9 percent of the responses

#### **Different Worlds?**

While not statistically binding, the survey results do portend some insight into the different realities that Latinos typically isolated from community process experience.

**Alternative Living Arrangements.** Latino respondents lived with extended family at a rate 1.59 times greater than other respondents; survey conductors theorize the ratio could be even greater based on further conversation with some of the respondents. Latinos were also 2.23 times more likely to be renters than other respondents.

**Public Safety.** Latinos surveyed felt the neighborhood was unsafe at an 59 percent rate; others felt so at a 45 percent clip. The gap was even wider when measuring peoples' optimism that the situation was improving; only 24 percent of Latinos saw improvement in the last two years, compared with 46.2 percent of all others.

**Community Process.** While 51.3 percent of other respondents were aware of the South Park Action Agenda, only 18.4 percent of Latino respondents knew of the process. Language was a much more significant barrier for Latino respondents as well.

### **Moving Forward**

The South Park Action Agenda will greatly benefit from the delivery of this survey in three ways, each of which should be the basis of strategic next steps.

The survey **provided needed validation of the community process to date**, and allowed a community that whose participation had been minimal to improve their involvement.

The survey detailed specific strategies that could address pressing concerns for neighborhood residents.

The survey **energized a cohort of residents, organizations, and public officials** to engage in the next steps associated with Action Agenda.

In moving forward, there are several opportunities building off of the benefits of the survey.

- Act quickly to communicate with respondents. There is a moment of interest and awareness among people who
  previously were unaware of how to engage in community building opportunities. Whatever the followup to the survey
  can provide as a way to mobilize these people will be a significant contribution to civic infrastructure in South Park.
  Those who responded should have access to the survey findings, be directed to subsequent Action Agenda activities,
  and be provided with ways to contribute.
- Coordinate the nonprofit infrastructure of the neighborhood in sharing information about community resources. While
  some serious community issues are identified by survey respondents, another trend was people being unaware of
  resources that are available in the neighborhood. A priority of the Action Agenda process should be building the
  communication between nonprofits that will allow for more effective dissemination of information.
- Use the Action Agenda process to determine priorities among the different working groups. Several impressive working documents have been assembled by the working groups in preparing the Agenda; now the challenge will be determining the sequence in which these priorities will be addressed. The survey findings can supplement the continuing dialogue between working groups in the Agenda process.
- Utilize the survey as an outreach and recruitment tool. The reach of the survey in such a short period of time is
  impressive, but need not be the end of the process. The survey could be used as an outreach tool in several South
  Park settings, and could be used to track changing perceptions in/of the neighborhood during the next several years.
  Questions of survey delivery and accurate data management would need to be addressed, and there are modest
  improvements needed in the survey instrument.
- Review the survey data more closely to surface opportunities for action. The time constraints involved in delivering
  this survey have limited the collection and analysis of data. If the instrument is to be used going forward, a more
  thorough recording of the data should be reviewed, including use of a database manager that can track trends over
  time.
- Spread the word. The news of the survey spread quickly; now it can spread further, both deeper into the community and also across the Seattle region as a model for community engagement.

#### ...in the Details

The qualitative responses provide a nuanced look at some of the concerns and aspirations of South Park residents. A review of this data is insightful in considering ways to increase resident engagement in community improvement for South Park. Highlights (in order of preference):

What are things that make you feel like past of the community? Given that 84 percent or respondents feel like a part of the community, it is important to understand why and encourage those factors going forward. Among the most consistently cited reasons: friendly neighbors, a sense of culture, amenities such as parks and libraries, frequent community events, the presence of community organizations, tenure, opportunities for community involvement. The sense of community was strong through most of the respondents.

What exists in other neighborhoods that does not exist here? While there were more than 20 different responses to this query, it is notable that some of the things cited by respondents actually exist in the neighborhood. This underscores the need to improve information dissemination throughout South Park. Leading responses: greater safety, business enterprises (multiple varieties), beautification, parks, greater education opportunities, swimming pools, improved recreation facilities, grocery services, infrastructure improvements.

What improvements are needed in public transportation? Overwhelmingly, increased bus service is perceived as a need in South Park. 3 of 4 people who provided a suggestion indicated that more buses are the answer. Weekend service was the second most highly cited suggestion. Interestingly, few people considered alternative options (e.g. carsharing).

What businesses are needed in the neighborhood? Answers here ranged across the board, with more than 25 different suggestions. Grocery services topped the list, followed by pharmacies, big retail, coffeehouses, bookstores, conveniences, clothiers.

**Solutions to public safety:** the answers were so widespread and redundant (e.g. multiple suggestions pre respondent) that the data is not instructive. There was also some wording around the question of desirability of police patrolling that may necessitate reposing that question in another venue.

What other community services are needed in the neighborhood? Again, responses to this question seem to indicate that there could be additional information sharing. About forty different suggestions were raised; interestingly, no suggestion had an overwhelming lead.

What would your be your highest priority to address the physical condition of the neighborhood? The most interesting aspect of this question was how many people cited public safety as a key to improving the physical condition of the neighborhood. This was not simply a misinterpretation of the question – there were as many responses citing some kind of public safety options as there were infrastructure recommendations. Among infrastructure responses, the leaders: pollution (air, water, or noise), bridge replacement, street/road improvements, drainage.

What would you say to the Mayor were he conducting this interview? Listing each of these responses would make for an interesting exercise (and might be worth a read by the Mayor). A few highlights:

That the residents support community improvement.

That the people who live in South Park are not bad. Families like to walk around without any concerns...

Increased surveillance could help make things more orderly.

This is a fast growing neighborhood that needs more attention.

It's very dangerous,

We care about our community...

Get rid of the criminal activity.

This is a low-income community that is often forgotten.

Great food.

There is a lot of violence here, and we need a lot of protection.

Fix the bridge.

Don't mess around with the crime problem.

We are worth investing in.

South Park has potential.

Tell him about the parents in the area and tell him to help the youth who have parents who use drugs.

We are a hard-working diverse caring community.

Interestingly, several Spanish- language survey respondents felt that the question and answer key corresponded and answered the question by rating importance. These are the responses that were ultimately analyzed and that are shown here.
