The rescheduled dates will remain tentative until confirmed by exam staff, due to the unpredictable and ever-changing nature of the pandemic, and attendant public health recommendations and guidelines. Commissioner Connole stated that the commission did not enter lightly or quickly into the decisions. Extensive research and consideration were put into the impacts to the candidates who have put extensive time into preparing for the exams. Commissioner Nark affirmed Commissioner Connole's statement.
