

**SEPA DETERMINATION OF NON-SIGNIFICANCE (DNS)
SEATTLE DEPARTMENT OF TRANSPORTATION (SDOT)
BIKE SHARE PROGRAM**

Description of proposal: The City is proposing to expand the bike share service area and replace and increase the number of stations with pedal-assisted bicycles. Seattle's bike share program is part of the overall vision of SDOT to deliver a high-quality transportation system for Seattle. The City envisions that bike share would become a new personal mobility option that increases access to affordable transportation, provides first and last mile connections, promotes active and healthy living, is environmentally friendly and equitable, supports the local economy, and is financially sustainable. The goal of the program is to increase the number of bicycles in the existing system, expand beyond the existing service area, and continue expanding coverage throughout the city consistent with City priorities. Long term, the City envisions expanding bike share into all neighborhoods where appropriate and feasible with upwards of 2,500 or more bicycles. Funds for long-term expansion may include grants, sponsorships, advertising, investment from contractor, Bewegen, or surplus from the system.
