    - Promote bicycling
    - Promote improved safety
    - Develop possible demonstration projects

  - In recent years, the board's work has been providing feedback to city staff who present projects or policies to the board
- How SBAB influences plans, project, and policies

## **Bike Lane Sweeping Update**

- Quinn update
- Maintaining growing network of PBL is a challenge
- Traditional street sweepers don't fit into PBLs, agency is investing in smaller sweepers
- Smaller sweepers have less capacity for leaves, creates challenge
- Agency has three bike lane sweepers
- · Levy includes two new positions for full time staff for bike lane sweeping
- Maintenance department working on new bike lane sweeping schedule
