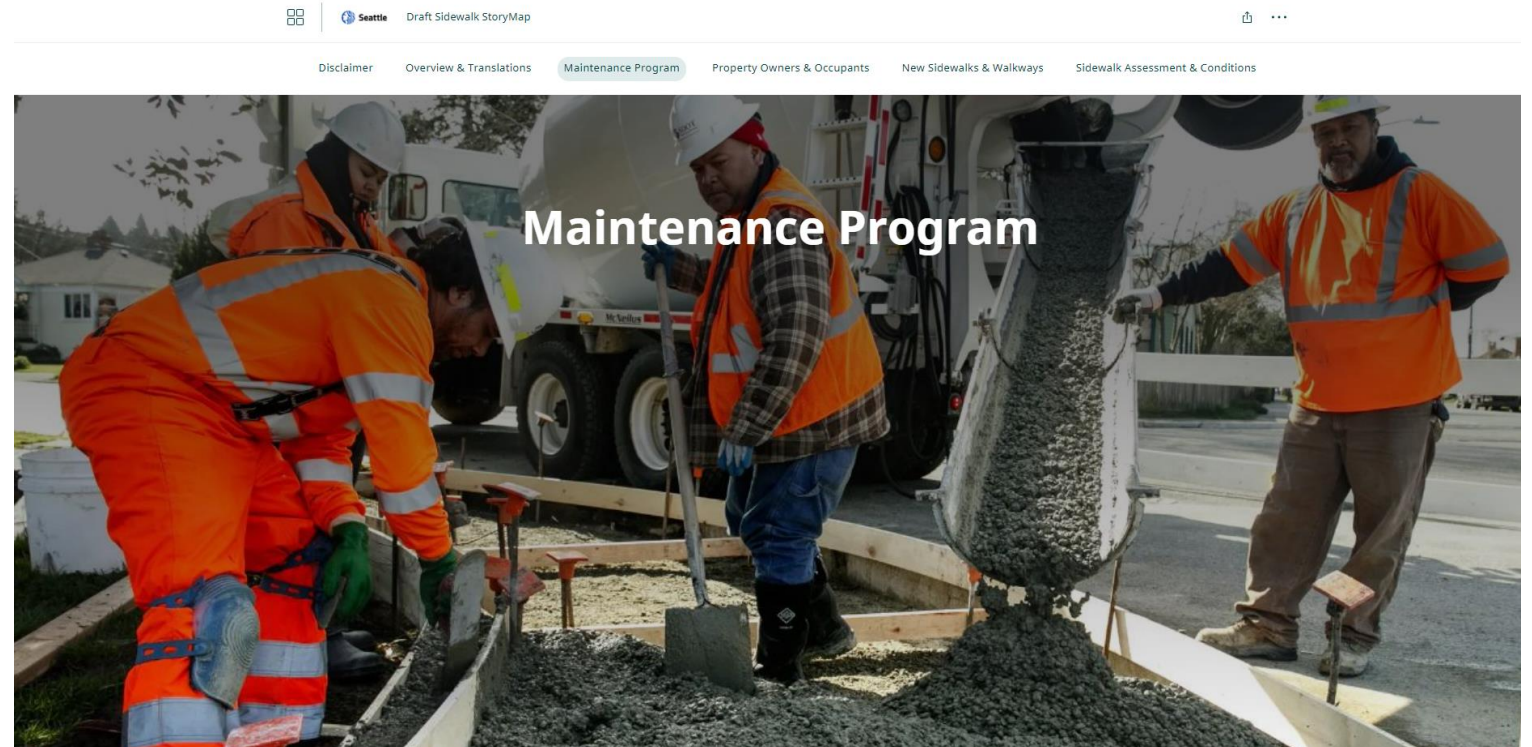

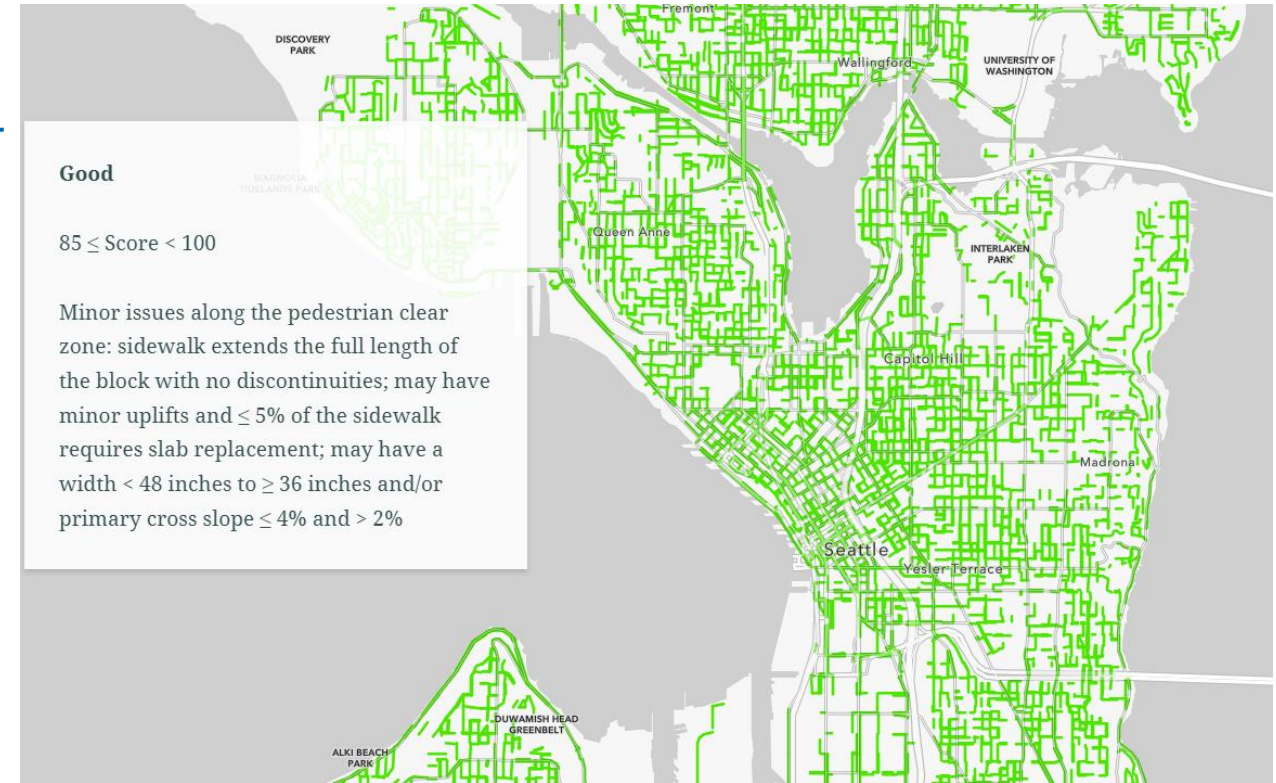

- 2018 Sidewalk Assessment & Recommendations Report presented to Council & SPAB
- 2020 SDOT / Evans School Sidewalk Repair Policy Recommendations, requested by Council under Resolution 31908
- 2021 City Auditor's Sidewalk Maintenance & Repair Program Recommendations:

Recommendation	Status	Explanation
Increase property owner awareness and education about sidewalk responsibilities	Pending	SDOT is developing a public facing interactive website called the Sidewalk StoryMap Expected completion: Second quarter 2022

Sidewalk StoryMap Scope

- Interactive Sidewalk StoryMap (ESRI product), multiple tabs featuring:
 - Sidewalk Overview & Disclaimer
 - SDOT's Maintenance & Mitigation Program
 - Information for Property Owners & Occupants including maintenance responsibilities, sidewalk clearing resources for snow and vegetation, how to repair sidewalks, construction responsibilities, sidewalk observations, and relationship to street trees
 - New Sidewalks & Walkway projects through the PMP Implementation Plan
 - Overview of the Sidewalk assessment, conditions, and data collection
- Public communications strategies
- 8 language versions: English and seven Tier 1 Languages

- **March 2022:** engage external stakeholders as beta testers

- **End of March:** facilitate beta tester focus group drop in sessions
 - March 30, 6:00PM – 7:30PM
 - March 31, 10:00AM – 11:30AM
- **March / April 2022:** Review and resolve recommendations
- **April / May 2022:** Publish StoryMap
- **July 2022:** If additional time needed, publish remaining 7 language versions
