  - S River St Area



### **What We Heard - Themes**

#### **Cut-Through Traffic and Speeding**


- On every street, even through parking lots
- Residential side street and alleys
- Industrial access must be maintained

#### **Pedestrian Mobility and Safety**


- Spot safety and crossing improvements
- Can space be preserved for pedestrians
- Improve walking corridors
- Repair and enhance sidewalks

#### Homelessness

- Major Safety Concern
- Collaboration is vital
- Tiny Homes have been very successful



# Draft Home Zone Plan




# **Stay Healthy Streets**

#### **Concerns**

- Cut-through traffic
- Lack of pedestrian facilities

- Traffic volumes, speeds, and collisions are low
- Install Stay Healthy Street Loop on Carleton and Flora
- Consider extending Oxbow Park into the street and future connections
- Cost: \$40,000 -\$70,000
- Early 2021 implementation



# Corson Ave S and Ellis Ave S Improvements

#### **Corson Ave S**

- Vehicle volume over 5000 cars/day
- 15% of the vehicles travel over 35 mph

#### Ellis Ave S

- Vehicle volume over 9000 cars/day
- 15% of the vehicles travel over 38 mph

- Install radar feedback signs near S Warsaw St
- Monitor for future crosswalk with rapid flashing beacon
- Costs \$50-\$75,000
- Early 2021 implementation




# **Sidewalk Conditions**

#### **Repair Sidewalks**

- S Michigan St, S Bailey St
- \$100-200k

# Abrupt sidewalk end at S Albro PI/S Eddy St

- Trim back vegetation
- Evaluate pedestrian improvements at intersection
- \$50-100k




### 6th Ave S

#### **Concerns**

- Left turn pocket backs up at Michigan
- No sidewalk from Michigan to Orcas
- No buffer between moving vehicles
- Trucks park in pedestrian space
- Safe parking need to be found for trucks

- Evaluate for buffer wheel stops or tough curbs
- Review design created by community
- Cost to Orcas may be over \$500k




# Other Pedestrian Crossings

#### 4th Ave S and S Orcas St

- Evaluate for pedestrian crossing
- Move transit stops
- Coordinate with #8 priority
- \$100-200k?

#### **Corson/Bailey/Michigan Intersection**

- Improve slip lane for pedestrian crossings
- Review signal timing for pedestrians
- \$50-100k?




# Railroad

#### **Concerns**

- Railroad tracks are a tripping/bicycle concern
- The tracks are the responsibility of the RR but it is a low priority for them

- Identify priority locations in Georgetown
- Determine if there are other concerns like noise/operation
- SDOT set up meeting with RR and community and business representatives to discuss cost sharing projects
- 200-500k?



# **S River St Area**

#### Concerns

- Cut-through Traffic
- All streets need two-way access
- Businesses have loading/unloading needs
- No space for pedestrians to walk
- Potholes and lack of drainage

- Traffic volumes are relatively low, as are collisions
- Improve pedestrian space along 6th \$100,000?
- Consider River St?






# **Georgetown Playfield**

#### **Concerns**

Overpass is scary

- Work with community to identify lighting and mural opportunities
- Cost \$100-200k?



# **Other Sidewalk Conditions**

#### **Repair Sidewalks**

- E Marginal Way S 2023 to 2025 construction
- Other sidewalk rehab?
- Repair paving on unimproved streets?
- How should we prioritize?
- \$200-400k?



# **Other Priorities?**

#### **Connection to Flume (Future Dog Park)**

- S Myrtle St
- \$100-200k?

#### Other planning priorities?

#### **Connection to Gateway Park N**

- 8th Ave S
- \$100-200k?





# **Funding for Georgetown - Known Priorities**

PROJECT	COST
Stay Healthy Street loop	\$40-\$70k
Radar Feedback signs on Corson and Ellis Ave S	\$50-\$75k
6th Ave S from Michigan to Orcas	\$300-\$500k
Sidewalk Rehab on Michigan, buffer?	\$100-\$200k
Albro and Eddy intersection	\$50-\$100k
4th and Orcas intersection	\$100-\$200k?
Corson/Bailey/Michigan	\$50-100k?
Total Cost	\$690-1,245k

Lighting and mural near Georgetown Playfield?	\$100-\$200k

8th Ave S?	\$100-200k
