CONSTRUCTION NOTICE

July 2, 2018

Sidewalk construction begins on 30th Ave NE as soon as July 9

OVERVIEW

As soon as Monday, July 9 crews will begin building a new sidewalk and a natural drainage system (NDS) along the east side of 30th Ave NE between NE 130th St and NE 137th St.

This work is the first step in completing a series of sidewalks on 30th Ave NE.

SCHEDULE AND IMPACTS

Construction begins at the northeast corner of NE 130th St and 30th Ave NE, and will occur Monday to Friday, 7 AM to 5 PM. Crews will work from south to north to construct the sidewalk and NDS. Construction is expected to last through the end of the year and is weather dependent.

Traffic will be maintained in all directions but may be reduced to one lane at times. Transit routes are expected to run according to their regular schedules. Prior to Waste Management's weekly Friday pick-up, residents will need to move bins to the edge of their property line near the street to ensure proper pick-up. Parking will be temporarily restricted, and crews will place "No Parking" signs 72 hours in advance.

Access to businesses and homes will be maintained at all times during this work, but driveway access will be temporarily restricted; we'll notify you individually ahead of time of potential impacts.



WHAT TO EXPECT DURING CONSTRUCTION

- Sidewalk construction between 130th 137th
- Typical work hours between 7 AM and 5 PM Monday through Friday
- Temporary parking restrictions
- Temporary pedestrian and bike detours around the work zone and staging area
- Temporary driveway restrictions. We'll notify you individually if you'll be impacted
- Access to businesses and homes will be maintained at all times
- Typical construction noise, dust, and vibrations



TREE PRUNING NOTICE

Protecting street trees is an important part of our job during construction. City code requires trees overhang no lower than 14 feet above the roadway and this clearance is especially important during construction due to machines and equipment passing underneath. Tree trimming is typically the responsibility of the adjacent property owner, but in this case pruning will be done by our crews in advance of construction.

If you prefer to prune trees yourself, please call 206-727-3575 and let us know at your earliest convenience. Pruning will need to take place by July 18, 2018. For residents we do not hear from, crews will prune the trees in advance of construction and pruning will be in accordance with SDOT Urban Forestry standards for tree protection.
