Event Notes:

• Alcohol Service; Parks Permit; PSEMP; SDOT TCP; food; vendors

- Running 4 blocks on California.
- Participating vendors Running down California Ave: 134 vendors, 16 food booths, stage on California, Beer garden, Kids Area on Alaska
- Complying with fire department needs
- Combination of Music and community oriented events
- Great for local merchants and Community

Committee Discussion:

- Chair: Last year there were some noise related items. Consider that there are more residential buildings in this area in regards to noise.
- Event: working with the West Seattle Farmers market. Ending their permit for the day that the Farmers Market runs (on Sunday there will be no beer garden or main stage)
- Christine: wanted to develop a better partnership with the farmers market, so Summer Fest has opted to release that space to the farmers market on Sunday
- Chair: will need an updated map from the Farmers Market for that date
- Dox: intent to leave barricades for the farmers market in partnership.
- Randy: They will need to have their own permit for this
- Dox: asking if they can close the street for stage building at noon on California to avoid noise issues. From Genesee to Oregon
- Chair: please send in an Update for this
- Lt. Wyatt: requesting an updated map for beer garden and Stage that is more detailed.
- Chair: Please CC special events on email with updated map
- Rieder: Working with officer Tyler Thomas
- Kristin confirmed that the set-up is the same as previous years. Will send more updated site maps with businesses that have storefront set ups, port-a-john, etc.
- Lt Wyatt: info booth size?
- Kristin: 10x15
- Al: has a final vendor list and will send them to Lt. Wyatt and CC SE office
- Laura Jenkins: checking in regarding neighborhood notifications, staff turnover, so want to make sure communication is met. Laura will communicate/follow-up with Christine the needs of communicating street closures and amplified sound.
- Christine: will work today to send it out by tomorrow with other communications tomorrow.
- Chair: Closed discussion.

Event: Seattle Catrinas

Date(s): Wednesday, Oct 26 – Wednesday, Nov 2, 2022

Location: Club Sur in SODO

Organizer(s): Carlos Alvarado [USA Latino Festivals]

Event Notes:

- Organization produced Cinco de mayo festival, music festivals, etc.
- Celebrating Day of the Dead in 2022 at Club Sur
- 3 different alters inside of Club Sur
- Staff will be dressing up as Catrinas: unique symbol from Mexico
- Procession from 6:30pm starting inside Club Sur and travel around the area for the street permit.
 Will decorate market with crafts and art from Mexico.
- Procession is slow walking and let by a mariachi band. During the day, the doors will be open from 1pm-8:30pm for kids, folklorico, female mariachi band, different performances from PNW performers and performers from Mexico
- Festival will close at 9pm so that the Club can reopen for businesses (owner requested this)
- 8 days lots of set-up and want to sustain celebration for the community

Committee Discussion:

- Chair: showed street view of street
- Event: asking to close just half of the street. Has also communicated with Gym next door, they are supportive.
- Event: Procession will start inside Club Sur, through the street market and back into the club.
- Event: has been in discussion with CORT (equipment rental company) for tents.
- Event: Procession will go THROUGH market, not onto street
- Lt. Wyatt: Are those 10x10 booths under the tents?
- Event: vendors will not have tents, they will have tables/chairs, but no tent.
- Event: removed 6 vendors from the middle of the plan. Will send updated map.
- Lt. Wyatt: Will there be fencing around the tent?
- Event: yes, there will be fencing around the whole 40x140 tent
- Lt. Wyatt: will discuss with CORT. Also, will need to see the 20ft firelane in map
- Chair: Follow up with our office with new maps and measurements.
- SDOT: believes there will be space. Will confirm the street can be open to traffic.
- Ann Martin: Will Club Sur be open and have alcohol sales?
- Event: Club Sur will sell alcohol to own patrons. There will be a bracelet system for event attendees indicating 21+, but the event will not be serving alcohol.
- Rieder: would like to make sure Club Sur alcohol doesn't mix with the event.
- Event: no alcohol allowed at street market. Event is paying Club Sur's security, but no alcohol will be at event.
- Chair: Please follow up with us.

Event: Greatest Party Known to Humankind (GPK)

Date(s): Saturday, August 6, 2022

Location: Georgetown

• Same as previous years with a new location

- Might have an event in Lucielle (no infrastructure)
- Beer garden is in a fenced in lot
- 25th Annual 17 years of unpermitted events, on the 18th year they worked with the city and made a good partnership
- Initially in Georgetown, closed airport way and the event got even bigger
- DIY event, not a money making venture, but always breaking even
- Small event during Covid-19
- Change in Location is an attempt to shrink the event a bit.
- Lucielle between 5th and 4th
- Events won't be on street

- Event: potentially, they'll be from hazard factory. Very diligent about permitting
- Lt. Wyatt: Beer garden details?
- Chair: showed street view of gated lot
- Event: There will security

- Ann Martin: Stage around Findley? No road closure requested

- Randy has a meeting with them set for next week (after some silence)
- Chair would like to take a poll regarding if we would approve the current event with current paperwork.
- Discussion about taking a poll. Determine a special
- Parks: existing map is inadequate.
- FAS: hasn't heard back about licensing. Concerns about hospital nearby and lack of engagement
- Chair: Has brought up hospital, not sure if they have engaged
- SPD: not sure they have the capacity to build a traffic plan, and have note provided refinement we have asked for.
- Chair: we offered alternatives and have been specific about our concerns as stated in the ordinance. We will tell them we will vote in our July meeting and give them 3 weeks to address concerns.
- SPD/Traffic: staffing is not possible that weekend.

- Carl Berquist: Downtown Parade hasn't paid yet (anticipates they will). Cap Hill Pride March and Rally haven't paid either (they might not)
- SDOT: still evaluating Laura's apartment building question. Will Follow –up
- Chair: Issue with Wildrose and the Unicorn. The Unicorn will have to stop just short of their location.
 Question regarding fire lane positions. Will follow-up with fire to try and find an agreeable solution for everyone.

Fremont Solstice Parade Status Updates:
