

# NOTICE OF UPCOMING WORK

# September 6, 2024 | SOIL AND GROUNDWATER INVESTIGATION IN YOUR NEIGHBORHOOD

## **PROJECT DESCRIPTION**

Next week, Seattle Public Utilities (SPU) will be working in your neighborhood. To inform the design of a future sewer main replacement, SPU will be drilling holes in the public right-of-way to investigate soil and groundwater conditions along the existing sewer pipe. Once the drilling is complete, the ground surface will be restored to its near-original condition.

The sewer main will be rehabilitated as part of a city-wide restoration effort that enables SPU to continue providing reliable sewer services to customers.

#### SCHEDULE

Crews will conduct the soil and groundwater investigation, including drilling at the project site, during the week of September 9, 2024.

#### LOCATION

Work will take place within the public right-of-way on W Cremona St. The map shows the work area and "no parking" zones.



## ANTICIPATED IMPACTS

During the work, you can expect:

- Large equipment staged in the public right-of-way.
- Construction-related traffic, noise, vibrations, dust, and occasional loud noise from drilling.

Seattle Public Utilities provides essential services — pure mountain drinking water, recycling and composting that lead the nation, and sewer and drainage systems to protect our local waterways — that safeguard your health and our shared environment and help keep Seattle the best place to live.

- Work hours and parking restrictions on W Cremona St are from 8 am to 5 pm. Please observe all no-parking signs. View the map for "no-parking" zones. As crews finish work in the area, parking restrictions will be lifted.
- A few 55-gallon drums containing soil will be temporarily stored in a fenced-off area within the public right-of-way. They will be stored for up to 40 days and occupy a parking space.
- Driveways will not be blocked. Sidewalks will remain open.
